## SERVICE ORDER NO. 48 /2017

### Subject :- 34th INTER ZONAL TRANSFERS-2017: ASI/MIN.

The personnel listed in Appendix " A " to this letter are posted to the Sectors as shown against each with immediate effect.

2. DG/CISF has directed to follow the following timeline strictly;-

(a)	Allotment of units by sectors	06.02.2017
b)	Relieving by units	31.03.2017
c)	Joining compliance	15.04.2017
d)	Compliance of IZT-17 to be submitted to FHQ by Sector IsG	30.04.2017

- 3. The sector IsG are requested to strictly comply to the above timelines and compliance (rank-wise) be submitted by 30/04/2017 positively in the prescribed proforma as circulated vide this Dte letter No.E-38021/(2)/Post. Comp/2012/Estt.II/(429) dated 14.02.2013. These datelines represent the outer limit for compliance. In case the sector IsG wish to relieve personnel prior to 31.03.17 they may do so.
- 4. Request cases of all personnel, which were decided to be reviewed in IZT-17 have been duly examined and necessary action taken on merit basis. However, all personnel could not be adjusted for want of vacancies in the desired places.

  Remaining cases, if any, may be treated as "Rejected/not considered" repeat "Rejected/not considered" having no merit. This may be brought to the notice of the Unit personnel.
- 5. The personnel who have not done hard area posting may be earmarked to have tenure in the hard area units so as to rotate the personnel who are already posted in the hard area units and completed their tenure.
- Representation: If any individual prefers a representation regarding IZT-17, he must submit his representation before 20/02/2017 to concerned Unit Commander. In order to avoid delay, the Unit Commander may forward all such representations in which action by the FHQ is required, directly to AIG(Estt.) quoting the serial number of posting order marking a copy to Zonal DIsG and Sector IsG for information. No representation will be entertained after 20.02.2017.

- 6.1 Representation received after **20/02/2017** shall **not be considered repeat not considered.**
- 6.2 FHQ will process and decide all such cases by **31/03/2017.** Sectors are requested to strictly comply with the timelines and **pendency** of representation should not be ground for non-relieving of the personnel.
- 7. In case, any of personnel are facing Departmental Enquiry, long OSL. AWL, pending court cases (only stay cases on posting), attachment with PMO/MHA/FHQ, proceeded on VRS, no more in service, their posting may be **treated as cancelled** and sector IsG may issue orders accordingly marking a copy to AIG/Estt. for purpose of information only.
- 8. The salaries in respect of affected personnel will not be claimed by the present DDOs after **31/03/2017** (**AN**) failing which the DDOs will be personally held responsible for the lapse except on deferment/ cancellation of postings by FHQ. Their movement orders/LPCs paid upto **31/03/2017**(AN) should be sent to their new DDOs without fail.
- 9. All Sector IsG are requested to verify the data of each individual shown in the posting orders and intimate the short comings, if any, in a consolidated manner by 28/02/2017 positively for examination and corrections wherever required.
