Subject :- **29th INTER ZONAL TRANSFER-2012.**

Reference CISF Circular No. 53/11 dated 20.12.2011.

02. It has been decided that 29th Inter Zonal Transfer-2012 in respect of all NGO from Constables to Inspectors should be issued by the 1st week of February'2012. It is therefore, requested that nominal roll of all affected personnel from the rank of Constables(Tradesman to Inspectors (Exe/Min/Steno/Fire) as per Appendices-"A", "A1", "B", "B1", "C", "C1", "D", "D1", "E", "E1", "E2", "E3", "F", "F1", "F2", "F3", "G", "G-1", "H", "H1", "H2", "H3", "H4", "H5", "H6", "H7", "I" and "J" may be sent so as to reach this HQrs (Estt-II branch) by **31-12-2011** positively.

Appendix-"A", "A1",

Nominal roll(s) of personnel (men) **{except North Zone and East Zone}** who would be completing seven years service as on 31.12.2011 in out of their home zone in Appendix-"A".

Nominal roll(s) of personnel (men) who belong to **North Zone and East Zone** and would be completing nine years service as on 31.12.2011 in out of their home zone in Appendix-"A1".

Appendix-"B", "B1",

Nominal roll(s) of personnel (men) **{except North Zone and East Zone}** serving in their home zone without completing seven years service in out of their home zone in Appendix-"B".

Nominal roll(s) of personnel (men) who belongs to **North Zone and East Zone** and serving in their home zone without completing nine years of service in out of their home zone in Appendix-"B1".

Appendix-"C", "C1",

Nominal roll(s) of personnel (men) **except North Zone & East Zone** who would be completing 12 years of service as on 31.12.2011 in their home zone after completion of seven years of service in out of their home zone in Appendix-"C".

Nominal roll(s) of personnel (men) who belongs to **North Zone and East Zone** and would be completing 10 years service as on 31.12.2011 in their home zone after completing of nine years service in out of their home zone in Appendix-“C1”.

Appendix-“D”, “D1”,

Nominal roll(s) of personnel (men) **except North Zone personnel & East Zone** who would be completing 13 years of service in out of home zone as on 31.12.2011 and due for their home zone in Appendix-“D”.

Nominal roll(s) of personnel (men) who belongs to **North Zone & East Zone** and would be completing 17 years service in out of their home zone as on 31.12.2011 in Appendix-“D1”.

Appendix- “E”, “E1”, “E2”, “E3”.

Nominal roll(s) of **Steno & Ministerial staff** (men) who would be completing seven years service as on 31.12.2011 in out of their home zone in Appendix-“E”.

Nominal roll(s) of **Steno & Ministerial staff** (men) serving in their home zone without completing seven years service in out of their home zone in Appendix-“E1”.

Nominal roll(s) of **Steno & Ministerial staff** (men) who would be completing 12 years of service as on 31.12.2011 in their home zone after completion of seven years of service in out of their home zone in Appendix-“E2”.

Nominal roll(s) of **Steno & Ministerial staff** (men) who would be completing 13 years of service in out of home zone as on 31.12.2011 and due for their home zone in Appendix-“E3”.

Appendix- “F”, “F1”, “F2, F3”.

Nominal roll(s) of women personnel who would be completing six years service as on 31.12.2011 in out of home zone in Appendix-“F”.

Nominal roll(s) of women personnel except those who were appointed on compassionate ground serving in their home zone without completing six years service as on 31.12.2011 in out of their home zone in Appendix-“F1”.

Nominal roll(s) of women personnel who were appointed on compassionate ground and serving in their out of home zone in Appendix-“F2”.

Nominal roll(s) of women personnel who were appointed on compassionate ground and married/re-married after compassionate appointment serving in their home zone without completing six years of service in Out of Home zone as on 31.12.2011 in Appendix-“F3”.

In case both husband and wife are serving in CISF, the same may be shown in the remarks column with full posting particulars of husband including his DOB, DOA & Home State indicating their Sl. No. and Appendix..

Appendix-“G, G1”.

Nominal roll(s) of Ex-servicemen (including North Zone & East Zone), who would be completing three years service as on 31.12.2011 in out of home zone in Appendix-“G”.

Nominal roll(s) of Ex-servicemen (including North Zone & East Zone), serving in their home zone without completing three years service in out of their home zone as on 31.12.2011 in Appendix-“G1”.

Appendix-“H, H1, H2, H3, H4, H5, H6, H7”. (TRADE WISE)

Nominal roll of Constable(Tradesman) appointed before 31.12.2010 age of 50 years and above as on 31.12.2011 and serving in their out of home zone in Appendix-“H”.

Nominal roll of Constable(Tradesman) appointed before 31.12.2010, between the age group of 40 to 50 years who would be completing six years service as on 31.12.2011 in out of home zone in Appendix-“H1”.

Nominal roll of Constable(Tradesman) appointed before 31.12.2010, between the age group of 30 to 40 years who would be completing seven years service as on 31.12.2011 in out of home zone in Appendix-“H2”.

Nominal roll of Constable(Tradesman) appointed before 31.12.2010, between the age group of 20 to 30 years who would be completing nine years service as on 31.12.2011 in out of home zone in Appendix-“H3”.

Nominal roll of Constable(Tradesman) appointed before 31.12.2010, between the age group of 40 to 50 years serving in their home zone without completing six years service in out of their home zone in Appendix-“H4”.

Nominal roll of Constable(Tradesman) appointed before 31.12.2010, between the age group of 30 to 40 years serving in their home zone without completing seven years service in out of their home zone in Appendix-“H5”.

Nominal roll of Constable(Tradesman) appointed before 31.12.2010, between the age group of 20 to 30 years serving in their home zone without completing nine years service in out of their home zone in Appendix-“H6”.

Nominal roll of Constable(Tradesman) who have been appointed directly as Constable(Tradesman) on or after 01.01.2011 and serving in their home zone in Appendix-“H7”.

Appendix-“I”

Nominal roll(s) of personnel from the rank of Constables to Inspectors upto the age of 57 years posted in the Units in NE Region, J&K & hypersensitive units of LWE area as identified from time to time (except the personnel who belongs to NER, J&K

& LWE Region) and have completed 2 hard area tenure (3 years each) as on 31.12.2011 in Appendix-“I” in separate sheet for each rank.

Appendix-“J”

Summary showing total number of personnel rank-wise and state-wise break-up will be submitted as per Appendix –“J” for each Appendix.

03. While preparing the nominal roll(s) the following point may be kept in mind.

- a) The service particulars may be sent in the Appendices as per the examples given in Appendix-“A” duly filled in all respects.
- b) The cases which have been decided by this Directorate to be considered during IZT-2012 should be indicated in the remarks column.
- c) Personnel whose cases have been cleared for promotion/under zone of consideration may be indicated in the remarks column.
- d) Details of those cases where DE/Court cases are pending and the personnel under suspension should be reflected in the remarks column of respective Appendix, cases of those CISF personnel in whose respect posting order have been cancelled as per Court Order or have been retained/transferred to a particular unit for a specified period should also be reflected in the remarks column positively.
- e) Particulars of children of the personnel who wards are studying in Classes i.e. 9th & 11th Std during the current academic session 2011-12 and would appear in board examination of classes 10th & 12th in 2013 should be shown in column No. 19 of the appendices.
- f) If any person is disabled or suffering from major disease, the same may also be shown in column No.20 of the appendices.
- g) The details of personnel who are trained Bandsmen, the instruments in which they are proficient should also be indicated in the remarks column and similarly, the details of personnel who are Wireless Operators, technicians, Electricians, Armourers, STF, Bomb Disposal, Dog Handler, Marine, Bugler, BDDS, Para Medical and the personnel who are deployed in greater public interest like VIP Security duties, Disaster Management etc may also be reflected in the remarks column.
- h) The details of personnel who are trained/working in Intelligence and Crime wing should be shown against their names in the remarks column.
- i) The details of active sports personnel playing in Central Team should be shown in the remarks column.

- j) The personnel who are having mentally retarded/physically handicapped children may be indicated in the remarks column.
- k) The names of personnel who have done Hard Area service 02 tenure (3 years in each unit) as the case may be, such period of service should be highlighted in column No. 18 appendices.
- l) In case of deputation outside CISF, the period of deputation will be counted in Home Zone/OHZ where the person was physically deployed. For example, for a personnel belonging to South Zone, the period spent on deputation in Delhi will be treated as in out of home zone but it will be counted in his home zone if he was on deputation in Chennai.
- m) While preparing the nominal roll(s), the service documents of the individual concerned may be checked thoroughly to ensure correctness of the particulars submitted to this Directorate.
- n) The consolidated nominal roll will be submitted by the **Sector IsG not by DIsG & Unit concerned**.
- o) All the Sector IsG are requested to submit a Certificate in the nominal rolls of each Appendix that **“POSTING PARTICULARS HAVE BEEN VERIFIED FROM SERVICE RECORDS AND NO CASE HAS BEEN LEFT OUT FOR INCLUSION IN THE NOMINAL ROLLS”**.

04. The personnel included in the above nominal roll(s) for Inter Zonal Transfer should not be posted out to any other unit till the orders of Inter Zonal Transfer are issued by this Directorate except on extreme administrative grounds and that should be intimated to this Directorate immediately giving earlier reference i.e. Sl No. of relevant Appendix.

05. The names of those personnel who have not completed out of home zone tenure and have been posted to home zone on compassionate ground may also be indicated with period in the remarks column. Similar information in respect of personnel posted out of Home Zone may also be indicated in the remarks column.

06. The nominal roll(s) in respect of Fire trained, Technical personnel would be sent directly to DIG/Fire & AIG(Tech) respectively, who will scrutinize and submit a consolidated nominal roll to this branch at appropriate time, but latest by 28-12-2011 positively along with their recommendations/suggestions for retention/adjustment in the prescribed Appendices.

07. Apart from the nominal rolls (hard copy), the particulars should also be sent in a new CD in EXCEL Files Generated by PIS Package. The CD may be checked properly before sending to this Directorate to ensure that it is free from any fault /corruption. The nominal roll should be sent through a special messenger.

08. Nominal roll(s) of personnel working in Res.Bns. should be sent by the concerned Sector IsG under whose jurisdiction they are located.

09. While calculating the out of home zone/home zone tenure the instructions issued vide this Directorate Circular No. 53/11 dated 20.12.2011 may be strictly followed.

10. The consolidated nominal roll(s) should be prepared strictly in accordance with the length of their out of home zone services i.e. personnel who have completed 17 years out of zone should be figured first and so on. The information in Appendices "A" and "D" should be given zone wise. This will apply in the case of Ex-servicemen personal also. For example personnel serving in NEZ and belonging to SZ,WZ,EZ,NZ their Appendices will be prepared as Appendix-A (SZ),A(WZ), A(EZ), A1(NZ) respectively.
