**SUB:- PROMOTION CUM POSTING FROM CONSTABLE TO THE RANK HC/GD: REG**

In pursuance, of FHQrs. New Delhi, S.O. No. 273/2011 issued under letter No. E-31014/05/Estt.II/2011-2819 dated 29.12.2011 and IG, CISF NES HQrs Kolkata S.O. No.03/2012 issued under letter No. E-38014/NES/AD-I/2012/213 dated 11/01/2012 the following Const/GD (earmarked to NEZ) is promoted to the rank of HC/GD on regular basis and posted to the Units as shown against their names. Their promotion will take effect from the date they assume the charge as HC/GD in the new place of posting:-

02. Before promoting them, it should be ensured that they fulfill the following requirements:-

- a) They are confirmed in the entry grade.
- b) Have successfully, completed the promotion cadre course of HC/GD and have been found to be in Medical Category SHAPE-I before being declared fit by the DPCs. If there is any deterioration in the medical categorization of an empanelled Const. after the DPC and before his/her actual promotion, the promotion will be withheld.
- c) No DE/Vigilance/Legal proceedings are pending/contemplated against of them. Promotion should also not be given during the currency of punishment if any.

- d) Promotion should not be given, in case an empanelled Constable is awarded any punishment after the DPC and before his/her actual promotion.
  - e) In the case of individuals shown as SC or ST in this promotion order it should be ensured that a certificate of SC or ST category issued by the appropriate authority is available in their service records. After verifying the same only the concerned individual be promoted /relieved on promotion-cum-posting to the concerned unit.
  - f) No fresh complaint has originated against the personnel and no fresh enquiry has been initiated or pending against the personnel.
  - g) If any of them is unwilling for promotion due to his own volition, a certificate to this effect (duly countersigned by the authority concerned) that he is willing to forego his promotion and will not claim seniority, may be obtained and forward to CISF HQrs (Estt.I).
  - h) The promotion is without prejudice to the claim of other Constables whose formal order for promotion to the rank of HC/GD are being issued separately. Their inter-se-seniority will be in order of panel drawn by the DPCs.
3. The Unit-Commandants (Appointing Authority) will issue Unit Service Order Part-I indicating the PSL/FSL Number of Constable/Lance Naik and date of promotion/ Assumption of charge in the rank of Head Constable/GD and will invariably forward copies of the S.O. Part-I to CISF HQrs (Estt.I/Estt-II and Tech Branch ). In the promotion order, it may be mentioned that Govt. Servant has to exercise the option within one month for fixation of his pay under FR -22.
5. In case any of the personnel mentioned above have been posted out to some other Unit(s), their present Unit commander shall be informed to relieve them immediately to their new place of posting under intimation to this Directorate for issuance of necessary amendment order
6. This has the approval of DIG/NEZ.
