**SERVICE ORDER PART-I NO. 02 /2012**

Subject :- **PROMOTION-CUM-POSTING FROM CONSTABLE TO THE RANK OF HEAD CONSTABLE/GD ON REGULAR BASIS AGAINST THE YEAR -2011.**

The Constables mentioned in Appendix-‘A’, who are promoted to the rank of Head Constable/GD on regular basis vide FHQrs Service Order No.273/2011 issued under letter No.E-31014/05/Estt-II/2011/2819 dt. 29.12.2011 and IG/SS Chennai Service Order Part-I No.03/2012 issued vide letter No.E-31014/PCP/Const. to HC(GD)/Estt/2012/292 dated 06.01.2012, are further posted to the Unit as shown against each. Their promotion will take effect from the date(s) they assume the charge as HC/GD in their new place of posting :-

2. Before promoting them, it should be ensured that they fulfill the following conditions :-

- a) They are confirmed in the entry grade or in the present rank.
- b) They have successfully completed the promotion cadre course of HC/GD and have been found to be in medical SHAPE-I before being declared fit for promotion by the DPCs. If there is any deterioration in the medical categorization of empanelled Constable after the DPC and before his/her actual promotion, the promotion will be withheld.
- c) No DE/Vigilance/Legal proceedings are pending/contemplated against any of them. Promotion should not be given during currency of punishment, if any.
- d) Promotion should not be given, in case an empanelled Constable is awarded any punishment after the DPC and before his/her actual promotion.
- e) In the case of individual shown as SC or ST in this promotion order it should be ensured that a certificate of SC or ST category issued by competent authority is available in their service documents. After verifying the same, the concerned individual be promoted/relieved on promotion-cum-posting to the concerned unit.
- f) No fresh complaint has originated against the personnel and no fresh enquiry has been initiated or pending against the personnel.
- g) “Before relieving/promotion the HCs/GD, especially who were rationalized/promoted to the rank of HC/GD during the year 1997, the Seniority list may be checked thoroughly and ensure that they are not allotted with double PSL numbers.”
- h) If any one of them is unwilling to move on promotion-cum-posting due to his/her own volition, a certificate to this effect (duly countersigned by the authority concerned) that he is willing to forgo his promotion and will not claim for seniority to be obtained from them and forwarded to FHQ directly (Estt.I Branch) in duplicate as well as this HQrs latest by 31.01.2012.
- i) The promotion is without prejudice to the claim of other Constables whose formal order for promotion to the rank of HC/GD are being issued separately. Their inter-seniority will be in order of panel drawn by the DPCs.

3. The Unit-Commandants(Appointing authority) will issue Unit Service Order Part-I indicating the PSL/FSL Number of Constable/Lance Naik and date of promotion/assumption of charge in the rank of Head Constable/GD and will invariably forward copies of the S.O.Part-I to FHQ (Estt.I & II and Tech Branch). In the promotion order, it may be mentioned that Govt. Servant has to Exercise the option within one month for fixation of his pay under FR-22.

4. "In case any of the personnel mentioned in Appendix-"A" have been posted out to some other Units(s), their present unit commander shall be informed to relieve them immediately to their new place of posting under intimation to FHQrs., and this HQrs for issuance of necessary amendment order."

5. In case any surplus in the rank of HC/GD, requested to adjust them in the higher vacancy available in the unit.

6. Compliance report along with charge assumption report may be forwarded directly to (Estt.I and R&S Branches), South Sector as well as this HQrs latest by 31.01.2012 positively.

4. The affected personnel may be relieved to their new place of posting immediately and report compliance to all concerned.
