The terms and conditions for the contractual appointment are given below:-

1. **Remuneration-** The consolidated remuneration to be paid to the contractual appointee is as under:-

(Depending upon classification of cities)

- (a) Rs. 53,025/- per month – For “X” Class cities
(b) Rs. 50,400/- per month – For “Y” Class cities
(c) Rs. 47,775/- per month- For “Z” Class cities

This consolidated remuneration shall remain fixed for the whole tenure of contract which limited to three years.

2. **Age-** All doctors appointed will not continue on the post once he/she reaches 65 years of age.

3. The contractual employment will be for a period of three years only or till regular incumbent joins or he/she reaches 65 years of age, whichever is earlier. The services of the appointee are also terminable before expiry of the contractual period by either side after giving 30 days' notice or salary in lieu thereof. The selection is purely contractual in nature and does not confer any right for regularization or permanent absorption.
4. **Leave**-The leave entitlement of the appointee shall be governed as per DoP&T O.M. No.12016/3/84-Estt(L) dated 12th April 1985, as amended from time to time.
5. No TA/DA is admissible for the interview. Suitable and willing candidates may **WALK FOR INTERVIEW** on the date & time at venue as given above along with original and attested photocopies of all relevant documents (like Graduate Degree, internship completion certificate, age proof and experience certificate if any etc.) and application in plain paper giving name of the post applied for with choices for place of posting in order of preference and five passport size recent photographs.
6. The competent authority reserves the right for any amendment, cancellation and change in this advertisement in whole or part thereof without assigning any reasons.
7. The competent authority reserves the right to fill or not fill any of the posts advertised.
8. **Educational/ professional qualifications for the post are as under:-**
 - (a) A recognized medical qualification included in the first or Second Schedule or Part II of the Third Schedule (other than that licentiate qualifications) to the Indian Medical Council Act, 1956. Holders of educational qualifications included in Part II or the Third Schedules should also fulfill the conditions stipulated in sub-section (3) of section (13) of the Indian Medical Council Act, 1956.
 - (b) Completion of compulsory rotating internship.
9. **Medical Examination**- Immediately after interview on the same day candidates will be medically examined by a Board of Medical Officers. Appointment will be subject to medical fitness.
10. The contractual appointee will be liable to serve any part of India, if necessary.
11. The candidates are required to submit the duly filled and signed Annexure (enclosed) in the prescribed proforma at the time of Interview.
