DEPUTATION TO MINISTRY OF EXTERNAL AFFAIRS (MEA) (.) IT HAS BEEN DECIDED TO SPONSOR INSPECTOR / EXE, HEAD CONSTABLES(GD) AND CONSTABLES(GD) ON DEPUTATION TO MEA FOR THE POST OF **SECURITY OFFICER AND SECURITY ASSISTANT (.)** THE TERMS & CONDITIONS ARE AS UNDER

THE TERMS AND CONDITIONS OF THE DEPUTATION FOR INSP/EXE (SECURITY OFFICER) ARE AS UNDER :-

1.	Upper age limit at the time nomination – 45 yrs.
2.	Pay as Inspector – PB-2 Rs.9300-34800/- with grade Pay Rs.4600/-. While posting at HQrs the officer will entitled to Dearness Allowances, City compensatory Allowance and Deputation Allowance as admissible, If no Govt. accommodation is readily available house rent allowance will be admissible at the Central government rates.
3.	Period of Deputations – The deputation period will be for five (05) years, commencing from the date of joining MEA. However, the Ministry will have the discretion of dispensing with the services of the officer at any time of deputation without assigning any reason thereof. The officer will also not claim a foreign posting as a matter of right.
4.	No benefit under "Next Below Rule (NBR)" will be admissible to the deputationist during their period of deputation with MEA in the event of their becoming due for promotion in their parent office/organization.
5.	The nominated officers should be clear from vigilance angle, i.e. there should be no DE/PE, Vigilance enquiry or Criminal case (s) pending against him

6.	The nominated officers should not be a prosecution witness in any important case(s), which is/are still pending trial and the officer may be required to attend the Court(s) in India for deposition frequently. It will not be feasible to do so when the officer is posted in the Mission abroad.

1.	Basic pay should be in the pay matrix 03 or 04 of the revised pay structure as per 7 th CPC (corresponding to Rs.2000/- & Rs.2400/- - GP of 6 th CPC)
2.	Matric or equivalent pass
3.	No disciplinary proceedings pending, clear from vigilance angle and no legal proceedings pending in a criminal court.
4.	Age : Below 45 years (as on 01.01.2017)
5.	Proficiency in reading, writing and communicating in English, completed un-armed combat course, having computer literacy and good skill to drive LMV with valid driving license. Medically fit (SHAPE – I) along with impressive bearing in terms of height (a minimum of 165.5 cms) and BMI with good service record (APAR grading should be high).
