  - xi) Duly filled in applications should be recommended by a Gazetted Officer not below the rank of Commandant or equivalent under whom the applicant's father was last posted when he expired. **The officer While recommending an application should, inter-alia, mention the brief circumstances of the death of the applicant's father.**
  - xii) A 'Check list' to ensure that the application being forwarded to this HQrs is complete in all respect, which may be filled up and submitted alongwith each application.

**Subject: Grant of Scholarship out of Police Memorial Fund for the academic year 2016-17.**

Applications in the prescribed proforma (enclosed) are invited from the children of non-gazetted policemen and IB officers killed on duty for the grant of scholarships for pursuing professional courses like MBBS, BE, B.Tech, MBA, MCA etc. @ ₹15,000/- p.a. and other general academic university courses viz BSc, B.Com, MSc, MA, etc. @ ₹5,000/- p.a. on regular basis.

2. Total number of scholarships under both the categories would be 15 (Professional Courses - 5 & General University Courses - 10). In case more than 15 applications are received, merit will determine the grant of scholarships. The Screening Committee will take the Fund position and number of applications into consideration while deciding the scholarship under each category. The Committee, while recommending the cases, would be guided by the academic records of the applicant and the status of the course as well as the status/prestige of the educational institution.

3. The applications must be accompanied by: -

- i) Certified copies of the mark-sheets of all the examinations passed from 10+2 level onwards.
- ii) A certificate from the concerned Educational Institution certifying that the applicant is a regular bonafide student of the institution during the academic year 2016-17 and that the institute is recognized by the local University/U.G.C.

4. Duly filled in applications should be recommended by an Officer not below the rank of Superintendent of Police/Commandant/Assistant Director or equivalent under whom the applicant's father was last posted when he expired. The Officer while recommending should, inter-alia, mentions the brief circumstances of the death of the applicant's father.
