

Madam,

The undersigned is directed to refer to this Ministry's letter of even number dated 02/02/2017 (copy enclosed), wherein the time line for submission of applications Online for Prime Minister Scholarship Scheme (PMSS) for the academic year 2016-17 was extended.

2. In this context, it is intimated that as the NIC has enabled National Scholarship Portal (NSP) version 2.0 for submission of Online PMSS applications (Fresh and Renewal) for the academic year 2016-17, but so many applicants are facing problems for uploading their PMSS application. Simultaneously Colleges/Institutes are also facing problems to verify the PMSS applications and requested for extension of time line for submission of PMSS applications.

3. Moreover, it has also come to the notice from the applicants through telephone/e-mail, that few Institutions/Colleges/Universities are not available on NSP portal and as such the Institutes/Colleges/Universities are unable to verify the application as they don't have their own ID and Password on NSP portal.

4. In view of the above, competent authority has approved to extend the time line as per details given below: -
