Subject : PROMOTION-CUM-POSTING FROM HC(FIRE) AND HC(DCPO)
TO THE RANK OF ASI(FIRE) ON REGULAR BASIC FOR THE
YEAR 2018- PANEL NO.01/2018, PANEL STRENGTH-36.

23 HC (Fire) and 12 HC/DCPO as per Appendix -"A" attached to this letter are promoted to the rank of Assistant Sub Inspector(Fire) on regular basis in the pay scale of Rs.5200-20200 + GP 2800 (PB-I) (now at level 5 in the new pay Matrix) for the year 2018 and posted to the Sector as shown against their names. Sector IsG will allot them Unit(s) in their Sectors. Their promotion will take effect from the date(s) they assume the charge as ASI(Fire) in their new place of posting:-

2. Before promoting them, it should be ensured that they fulfill the following requirements:-

- (a) They are confirmed in the entry grade or in the present rank.
- (b) They have successfully, completed the promotion cadre course of ASI/Fire(Lab).
- (c) They should have been in medical category SHAPE-I before being declared fit by the DPC's and if there is any deterioration in the medical categorization of an empanelled HC/Fire & DCPO after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in Para 3 [d] of CISF HQrs, letter No. 514 dated 11.07.2017, any person who has been declared FIT by the DPC subject to attaining of SHAPE-I medical categorization, shall be promoted only after re-gaining his/her SHAPE-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2018. In case he/she does not re-gain the SHAPE-I medical categorization by 31.12.2018, his/her case will be considered afresh by the next DPC.
- (d) No Disciplinary case is pending against any of them. Promotion should not be given during currency of punishment.
- (e) No fresh complaint has originated against the personnel and no fresh enquiry has been initiated or pending against the personnel.
- (f) Promotion should not be given, in case an empanelled HC/Fire & DCPO is awarded any punishment after the DPC and before his actual promotion.

(g) In the case of SC/ST officer, a certificate to that category issued by the competent authority is available in their service records. After verifying the same, the concerned individual be promoted/relieved on promotion-cum-posting to the concerned unit.

(g) If anyone is unwilling to move on promotion due to his own reason, a certificate to this effect (duly signed by the authority concerned that he is willing to forego his promotion and will not claim seniority), may be obtained and forwarded to this HQ (Estt-I Section).

3. The Unit Commandants (Appointing Authority) will issue Unit Service Order Part-I indicating the PSL/FSL Number of HC/(Fire/DCPO) and date of promotion/assumption of charge in the rank of ASI/Fire will invariably forward to this HQ (Estt-I/Estt-II). In the promotion order, it may be mentioned that Govt. Servant has to exercise the option within one month for fixation of his pay under FR-22.

4 In case, any of the HC/Fire & HC/DCPO mentioned in Appendix-'A' have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector IsG from the present place of posting under intimation to this Dte. However, in case any of the individuals have been posted out to another Sector repeat another Sector, cases of such personnel may be taken up with this Dte for amendment of PCP.

5. The promotion of HC/Fire & DCPO is subject to further orders which may be passed by the Ho'ble Supreme Court, as mentioned in DoPT OM No. 36012/11/2016/Estt.I (Res.I) (Pt-II) dated 15.06.2018.

6. All affected personnel may be relieved immediately and a consolidated compliance report may please be submitted by 30.11.2018 by the concerned Sector IsG.

7. This has been issued with the approval of Competent Authority.
