#### SERVICE ORDER PART-I NO. 36 /2020

# Sub:- PROMOTION-CUM-POSTING FROM ASI/CLK TO THE RANK OF SI/MIN FOR THE YEAR-2020.

The ASIs/Min mentioned in Appendix-A, have been found "Fit" by the DPC for the year 2020. They are promoted to the rank of Sub-Inspector (Min) on regular in the pay scale of Rs.9300-34800 + GP 4200 (PB-2) (now at level 6 in the new Pay Matrix, Rs.35,400 - 1,12,400) and posted to the Sectors/Units as shown against their names against the existing vacancies.

- 2. It may be ensured that the empanelled personnel are fulfilling the following conditions before granting them promotion:
  - i) They are confirmed in the entry grade or in the present rank.
  - ii) They have successfully completed the promotion cadre course of Sub Inspector/Min.
  - iii) They should have been in medical category Shape-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled ASI/Clk after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in para 2 (d) of CISF HQrs letter No.686 dated 04.09.2019, any person who has been declared fit by the DPC subject to attaining of Shape-I medical categorization, shall be promoted only after re-gaining his/her Shape-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2020. In case, he/she does not re-gain Shape-I medical categorization by 31.12.2020, his/her case will be considered afresh by the next DPC.
  - iv) No DE/Vigilance/Criminal proceedings are pending against them.
  - v) Promotion should not be given, in case an empanelled ASI/Clk is awarded any punishment after the DPC and before his/her actual promotion. If an empanelled ASI/Clk is awarded any punishment after the DPC and before his/her actual promotion, the matter may be referred to FHQ (Estt.I Branch) for deletion of his/her name from the promotion panel as well as cancellation of PCP.
  - vi) Promotion should also not be given during the currency of punishment, if any.
  - vii) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.
- 3. They will be on probation for a period of two years in the rank of SI/Min from the date of assumption of charge and their promotion will be subject to satisfactory completion of the said period of probation.

- 4. In case any of them is un-willing to move on promotion-cum-posting, a certificate should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and seniority later on and the same may be forwarded to this HQrs. (Estt.I Branch) accordingly.
- 5. The charge assumption report and Service Order Part-I regarding promotion may be submitted to this HQrs. (Estt-I Branch) by the concerned Units and appointing authority respectively immediately on their assumption of Charge.
- 6. The promotion of ASIs/Clk to the rank of Sub Insp/Min is subject to Judgment Order dated 26.09.2018 of Hon'ble Supreme Court of India in SLP ( C ) No.30621/2011 and further orders which may be passed by the Hon'ble Supreme Court as mentioned in DoPT OM No.36012/11/2016-Estt.(Res-I) {Pt-II} dated 15.06.2018.
- 7. In case, any of the ASI/Min mentioned above have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector from the **present place** of posting under intimation to this Dte. However, in case any of the individual has been posted out to another **Sector repeat another Sector**, case of such personnel may be taken up with this Dte for amendment of PCP.
- 8. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of SI/Min.

9. Compliance report alongwith charge assumption report may be forwarded to Estt-I Branch of this HQrs accordingly.
