2. The personnel listed in Appendix- 'A' to this letter are posted to CISF MPRTC Behror under Trg. Dte. Delhi from the units as shown against each. All Unit(s) Commanders are requested to comply with the following timelines strictly:-

3. DIG CISF MPRTC Behror requested to strictly comply to the above timelines and compliance report (Rank-wise) be submitted to this Dte. by 31.05.2020 positively in the prescribed proforma as circulated vide FHQr, New Delhi letter No.E-38021/(2)/Post. Comp/2012/Estt.II/429 dated 14.02.2013. These datelines represent the outer limit for compliance. In case the DIG wish to relieve personnel prior to 30.04.2020, they may do so after keeping in mind that such personnel should not be on election duty and/or his/her relieving may not adversely affect the operational requirements of the RTC.

4. **Representations:-** If any individual prefers a representation regarding IST-2020, he/she must submit his/her representation before 25/03/2020 to concerned Unit Commander. In order to avoid delay, the Unit Commander may forward all such representations in which action by the FHQ is required to AIG(Estt.) quoting the serial number of posting order marking a copy to this Dte. for information. No representation will be entertained after 25.03.2020. Representation received after 25.03.2020 shall not be considered repeat not be considered.

5. FHQ will process and decide all such cases by 30.04.2019. Concerned DIsG are requested to strictly comply with the timelines and pendency of representation should not be ground for non-relieving of the personnel.

6. In case, any of the personnel are facing Departmental Enquiry, long OSL, AWL, pending court cases(only stay cases on posting), attachment with PMO/MHA/FHQ, proceeded on VRS, no more in service, their posting may be treated as cancelled and the same be intimated to this Dte for issue of orders in this regard.

7. The salaries in respect of affected personnel will not be claimed by the present DDOs after 30.04.2020(AN) falling which the DDOs will be personally held responsible for the lapse except on deferment/cancellation of postings by FHQ. Their movement orders/LPCs paid up to 30.04.2020(AN) should be sent to their new DDOs without fail.

8. Other instructions in this regard issued by FHQrs New Delhi vide aforesaid Service Order should be complied strictly.
