


ORDER POSTING PERSONNEL FROM VARIOUS UNITS TO CISF UNIT DMRC DELHI (TO REPLACE IS DUTY PERSONNEL) VIDE THIS DTE. SO NO.319/2020 DATED 20.03.2020 AND MESSAGE NO.E-38018/ESTT-II/20/2020/47 DATED 27.04.2020 (.) DG/CISF HAS APPROVED THAT IN VIEW OF OPERATIONAL NECESSITY AND IN ORDER TO REPLACE IS DUTY PERSONNEL DEPLOYED IN CISF UNIT DMRC DELHI. THE POSTING ORDER ISSUED VIDE SO NO.319/2020 DATED 20.03.2020 IS REQUIRED TO BE IMPLEMENTED (.) IN ORDER TO MINIMISE THE HARDSHIP OF PERSONNEL AND TO REGULATE THE FINANCIAL COMMITMENT ON ACCOUNT OF TRANSFER TA IT WOULD BE IMPLEMENTED IN PHASES (.) THE FOLLOWING INSTRUCTIONS HAVE ALSO BEEN APPROVED (.) **ALFA**(.) IN VIEW OF BUDGETARY CONSTRAINTS REGULATING QUARTERLY EXPENDITURE AND THE PREVAILING COVID-19 SCENARIO.
