**SERVICE ORDER PART-I NO. 104/2020**

Sub:- **PROMOTION-CUM-POSTING FROM ASI/EXE TO THE RANK OF SI/EXE  
ON REGULAR BASIS AGAINST THE VACANCY YEAR 2020: REG**


The ASIs/Exe mentioned in Appendix –“A” are found fit by the DPC against the vacancy year 2020. They are promoted to the rank of Sub-Inspector (Exe) on regular basis in the Level-6 of pay Matrix, Rs.35,400 – 1,12,400 and posted to the Sectors/Units as shown against their names. They may be adjusted against similar or higher rank in the present unit Their promotion will take effect from the date(s) they assume charge as SI/Exe in the new place of posting.

2. It may be ensured that the empanelled personnel are fulfilling the following conditions before granting them promotion:-

- i. They are confirmed in the entry grade or in the present rank.
- ii. They have successfully completed the promotion cadre course of ASI/Exe to SI/Exe.
- iii. They are in medical category SHAPE-I before being declared fit by the DPC and if there is any deterioration in the medical categorization of an empanelled ASI/Exe after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in para 2(d) of CISF HQrs letter No.660 dated 17.09.2018, any person who has been declared fit by the DPC subject to attaining of Shape-I medical categorization, shall be promoted only after regaining his/her Shape-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2020. In case, he/she does not regain Shape-I medical categorization by 31.12.2020, his/her case will be considered afresh by the next DPC.
- iv. No DE / Vigilance / Criminal Proceedings are pending against them and promotion should not be given during **currency of punishment**.
- v. If any of the empanelled ASI/Exe is unwilling to move on promotion due to own volition, a certificate to this effect (duly countersigned by the authority concerned) that he/she is willing to forgo promotion and will not claim for seniority may be obtained and forwarded to this HQrs (Estt.I.Section).
- vi. In case of SC/ST candidate, it should be ensured that a certificate to this effect in prescribed format from the competent authority is available in their service documents.
- vii. Promotion should not be given, in case an empanelled ASI/Exe is awarded any punishment after the DPC and before his/her actual promotion. Matter may be referred to FHQ (Estt.I Branch) for deletion of his/her name from the promotion panel as well as cancellation of PCP through concerned Sector HQrs.

3. It may also be incorporated in the promotion order that on promotion, **they will be on probation for a period of two years in the rank of SI/Exe from the date of assumption of charge** and their promotion will be subject to satisfactory completion of the said period of probation.

- 4 The promotion of ASIs/Exe to the rank of SI/Exe against the year 2020 is subject to :-
- Order passed on 26.09.2018 by the Hon'ble Supreme Court in SLP(C) No.30621/2011 and further orders which may be passed by the Hon'ble Supreme Court, as mentioned in DOPT OM F.No.36012/11/2016-Estt(Res-I){Pt-II} dated 15.06.2018.
  - Outcome of WP No.4793/2017 filed by No.882330523 ASI/Exe S.Perinbam of CISF Unit ASG Chennai before the Hon'ble High Court of Madras.
5. The charge assumption report and Service Order Part-I regarding promotion may be submitted to this HQrs. (Estt-I Branch) by the concerned Units and appointing authority respectively immediately on their assumption of Charge.
6. They may be adjusted in the same unit against similar/higher vacancies which are available in the unit, as far as possible.
7. In case, any of the ASI/Exe mentioned above have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector from the **present place** of posting under intimation to this Dte. However, in case any of the individual has been posted out to **another Sector repeat another Sector**, case of such personnel may be taken up with this Dte for amendment of PCP
8. If the Sectors are not able to adjust in the same units against the similar or higher available vacancies, such personnel may be posted to the other nearby units under their control as per their convenience.
9. The personnel who were earmarked in IST-2020 & 1st Inter change in between NS/NCRS and affected in the PCP may be given promotion in the present unit and they may be relieved to their new allotted units after completion of deferment period as per this Dte msg No. 54 and 55 dated 20.05.2020 respectively in their promoted rank. Concerned Sector IsG will adjust them in similar or higher vacancies accordingly.
10. Their posting as per due Sector would be considered in the future after assessing the COVID-19 scenario.
11. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of SI/Exe in the unit.
12. Compliance report along with charge assumption report will be forwarded to Estt-I Branch of this HQrs latest by **30.11.2020**.
