Subject : Grant of Additional pension after the age of 80 years to the employees, who are drawing Provision Pension

A clarification was sought by the CRPF whether personnel who are drawing provisional pension are eligible for grant of additional pension on completion of 80 years of age.

2. The matter has been examined in consultation with DoP&PW. DoP&PW vide ID No. 38/03(35)/2020-P&PW(A) dated 06.08.2020 has intimated that there is no specific provision in CCS Pension Rules, which allows or disallows additional pension after completion of 80 years of the pensioners who are getting provision pension. However, DoP&PW has issued clarifications that pension fixation rules, at the time of 6th & 7th CPCs, are also applicable for pension revision in case of pensioners getting provisional pension. Therefore, pensioners getting provisional pension are also entitled for additional pension after completion of 80 years.

2. The matter has been examined in the Department. Rule 69 of the CCS(Pension) Rules, 1972 provides as under:


(1) (a) *In respect of a Government servant referred to in sub-rule (4) of Rule 9, the Accounts Officer shall authorize the provisional pension equal to the maximum pension which would have been admissible on the basis of qualifying service up to the date of retirement of the Government servant, or if he was under suspension on the date of retirement up to the date immediately preceding the date on which he was placed under suspension.*

(b) *The provisional pension shall be authorized by the Accounts Officer during the period commencing from the date of retirement up to and including the date on which, after the conclusion of departmental or judicial proceedings, final orders are passed by the competent authority.*

Further, the GOI decision issued vide G.I., M.F., O.M. No.11 (6)-E-V(A)/73 dated the 22nd July, 1974 (under Rule 69) provides for grant of cent per cent provisional pension under Rule 69 mandatory even if departmental or judicial proceedings are continued.

3. There is no specific provision in CCS Pension Rules which allows or disallows additional pension after completion of 80 years of the pensioners who are getting provisional pension. However, clarifications have been issued by this Department that pension fixation rules, at the time of 6th & 7th CPCs, are also applicable for pension revision in case of pensioners getting provisional pension. Therefore, pensioners getting provisional pension are also entitled for additional pension after completion of 80 years.

4. This issues with the approval of the competent authority in the Department.
