**SERVICE ORDER PART-I NO. 122 /2020**

Subject : **PROMOTION-CUM-POSTING FROM CONSTABLE/FIRE TO THE RANK OF HEAD CONSTABLE (FIRE) ON REGULAR BASIS FOR THE YEAR -2020.**

The Const/Fire mentioned in **Appendix –“A”** have been found fit by the regular DPC-2020 for promotion to the rank of Head Constable/Fire. They are promoted to the rank of HC/Fire on regular basis in the pay matrix of Rs. 25500-81100 (**for GP-2400, level-4**) and posted to the Sectors as shown against their names. They may be adjusted against similar or higher ranks in the present unit (except NES). Their promotion will take effect from the date(s) they assume charge of Head Const/Fire in the new place of posting.

2. It may be ensured that the empanelled personnel are fulfilling the following conditions before granting them promotion:-

- i) They are confirmed in the entry grade or in the present rank.
- ii) They have successfully completed the promotion cadre course of HC/Fire
- iii) They should have been in medical category Shape-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled Const/Fire after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in para 2(d) of CISF HQrs letter No.687 dated 04.09.2019 any person who has been declared fit by the DPC subject to attaining of Shape-I medical categorization, shall be promoted only after re-gaining his/her Shape-I medical categorization, before completion of the vacancy year i.e. not later than **31.12.2020**. In case, he/she does not re-gain SHAPE-I medical categorization by **31.12.2020**, his/her case will be considered afresh by the next DPC.
- iv) No DE/Vigilance/criminal proceedings are pending against them.
- v) Promotion should not be given, in case an empanelled Const/Fire is awarded any punishment after the DPC and before his/her actual promotion. If an empanelled Const/Fire is awarded any punishment after the DPC and before his/her actual promotion, the matter be referred to FHQ (Estt.I Branch) through sector IsG for deletion of his/her name from the panel as well as cancellation of PCP.
- vi) Promotion should also not be given during the currency of punishment, if any.
- vii) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.

- viii) In case any of them is un-willing to move on promotion-cum-posting, a certificate should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and seniority later on and the same may be forwarded to this HQrs. (Estt.I Branch) through sector IsG accordingly.
- ix) The charge assumption report and Service Order Part-I regarding promotion may be submitted to this HQrs. (Estt-I Branch) by the concerned Units and appointing authority respectively immediately on their assumption of Charge.
- x) **The promotion of Const/Fire to the rank of HC/(Fire) is subject to Judgement Order dated 26.09.2018 of Hon'ble Supreme court of India in SLP (C) No. 30621/2011 and further orders which may be passed by the Hon'ble Supreme Court, as mentioned in DoPT OM No.36012/11/2016-Estt.(Res-I) {Pt-II} dated 15.06.2018.**
3. In case, any of the Constable/Fire mentioned above have been posted out to other unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector from the present place of posting under intimation to this Dte. However, in case any of the individual has been posted out to another Sector repeat another Sector, cases of such personnel may be taken up with this Dte for amendment of PCP.
4. If the Sectors (except NES) are not able to adjust them in the same units against the similar or higher available vacancies, such personnel may be posted to the other nearby units under their control.
5. The personnel who have been earmarked to other sectors from NES, due to non availability of vacancies, may be relieved on PCP to the concerned units to be allotted by new sector.
6. The personnel who were earmarked in IST-2020 & 1st Inter Sector Change in between NS/NCRS and affected in PCP may be given promotion in the present unit and they may be relieved to their new allotted units after completion of deferment period as per this Dte msg No. 54 and 55 dated 20.05.2020 respectively in their promoted rank. Concerned Sector IsG will adjust them in similar or higher vacancies accordingly.
7. Their posting as per due Sector would be considered in the future after assessing the COVID-19 scenario.
8. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge in the rank of HC/Fire in the unit.
9. Compliance report along with charge assumption report and SO PT.I may be forwarded to Estt.I Branch of this HQrs by 31.12.2020 by the concerned Sector IsG.


