SERVICE ORDER PART-I NO. 128/2020

Subject:-**PROMOTION-CUM-POSTING FROM HC(DVR) TO THE RANK OF ASI/MT
AGAINST THE YEAR -2020.**

The following HC(Dvr.) mentioned in Appendix-A are found fit by the regular DPC for the year 2020. They are promoted to the rank of Assistant Sub Inspector (MT) on regular basis in the pay Matrix of Rs. 29,200-92,300 (Level-5) and posted to the Sectors as shown against their names. They may be adjusted against similar or higher rank in the present unit except Sl. No.09 who has been earmarked for posting to NCRS on PCP. Their promotion will take effect from the date(s) they assume charge as ASI/MT in the new place of posting.

2. It may be ensured that the empanelled personnel are fulfilling the following conditions before granting them promotion:-

- i) They are confirmed in the entry grade or in the present rank.
- ii) They have successfully completed the promotion cadre course of ASI(EXE/MT).
- iii) They should have been in medical category SHAPE-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled HC/Dvr after the DPC and before his/her actual promotion, the promotion will be withheld. Further, as per MHA's directions dated 27.04.2012, incorporated in para 2 (d) of CISF HQrs letter No.686 dated 04.09.2019, any person who has been declared fit by the DPC subject to attaining of SHAPE-I medical categorization, shall be promoted only after re-gaining his/her SHAPE-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2020. In case, he/she does not re-gain SHAPE-I medical categorization by 31.12.2020, his/her case will be considered afresh by the next DPC.
- iv) No DE/Vigilance/Criminal Proceedings is pending against them.
- v) Promotion should not be given, in case an empanelled HC/Dvr is awarded any punishment after the DPC and before actual promotion. If an empanelled HC/Dvr is awarded any punishment after the DPC and before actual promotion, the matter may be referred to FHQ (Estt.I Branch) for deletion of name from the promotion panel as well as cancellation of PCP through Sector IsG.
- vi) Promotion should also not be given during the currency of punishment, if any.
- vii) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.

3. In case any of them is un-willing to move on promotion-cum-posting, a certificate in prescribed format should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and seniority later on and the same may be forwarded to this HQrs.(Estt.I Branch) accordingly.

4. The charge assumption report and Service Order Part-I regarding promotion may be submitted to this HQrs.(Estt-I Branch) by the concerned Units and appointing authority immediately on their assumption of Charge.

5. The promotion of HC/Dvr to the rank of ASI/MT is subject to further orders which may be passed by the Hon'ble Supreme Court as envisaged in the DoPT OM No.36012/ 11/2016 -Estt.(Res-I) {Pt-II} dated 15.06.2018.
6. They may be adjusted as far as possible in the same unit against similar/higher vacancies which are available in the unit in view of Covid-2019 and budgetary constraints.
7. In case, any of the HC/Dvr have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector from the **present place** of posting under intimation to this Dte. However, in case any of the individual has been posted out to **another Sector repeat another Sector**, case of such personnel may be taken up with this Dte for amendment of PCP.
8. If the Sectors are not able to adjust in the same units against the similar or higher available vacancies, such personnel may be posted to the nearest units under their control as per their convenience.
9. The personnel who were earmarked in IST-2020 & 1st Inter change in between NS/NCRS and affected in the PCP may be given promotion in the present unit and they may be relived to their new allotted units after completion of deferment period as per this Dte msg No. 54 and 55 dated 20.05.2020 respectively in their promoted rank. Concerned Sector IsG will adjust them in similar or higher vacancies accordingly.
10. **Their posting as per due Sector would be considered in the future after assessing the COVID-19 scenario.**
11. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of ASI/MT in the unit.
12. Compliance report along with charge assumption report will be forwarded to Estt-I Branch of this HQrs latest by **31.12.2020**
