विषय:- Instruction with regard to relieve of personnel earmarked for posting in Inter Sector Transfer-2020 & 1st Inter Changing between NS & NCRS: Regarding.

Kindly refer to this Dte. message No.54 dated 20.05.2020 and even No.55 dated 20.05.2020.


02. The matter with regard to relieve of personnel earmarked for posting in Inter Sector Transfer-2020 and 1st Inter Changing between NS & NCRS have been examined at this Dte. and following instructions are hereby issued:-

03. Keeping in view the mobilization of Coys. on election duty/IS duty, the relieving date of personnel affected in IST-2020 and 1st Inter Changing between NS & NCRS is amended as follows:-

- i) All cases under deferment of posting to be relieved by 31.03.2021 will now be relieved by 10.05.2021.
- ii) However, those who want to get relieved earlier than 10.05.2021 on educational ground of wards may be relieved anytime after 31.03.2021 but before 10.05.2021.

04. Further, the personnel (who are under orders of posting in IST-2020 and 1st Inter Changing between NS & NCRS)whose wards are studying in 9th & 11th standard during the academic year 2020-2021(would be promoted in 10th and 12th standard in next academic year 2021-2022) is hereby deferred further upto 31.03.2022 (subject to their family members including ward staying in family accommodation allotted by unit or granted HRA and also willingness of the individual concerned that he/she is willing to stay further one year in his present place of posting) with a direction that they should be relieved on 31.03.2022(AN) without waiting for any further direction from FHQR. New Delhi.
