**विषय:- Instruction with regard to issue of Inter Unit Transfer-2021 by the Sector IsG: Regarding.**

Kindly refer to this Dte. message No.94 dated 08.01.2021, No.06 dated 19.02.2021 and letter of even No. 1489 dated 17.03.2021.

2. As per Para-2 (d) (xiii) (d & e) of this Dte letter No. 1489 dated 17.03.2021, time lines for relieving of personnel in the Inter Unit transfer-2021 have been mentioned i.e. 1st Phase by 10.05.2021 and 2nd phase by 31.05.2021.
3. In view of the surge in COVID-19 cases in the country, the matter regarding relieving of personnel in the Inter Unit transfer-2021 has been examined at this Dte. from a compassionate angle and approved as under :-
  - a) Affected personnel should be relieved in two phases, i.e. **1st phase by 10.06.2021** and **2nd phase by 30.06.2021** instead of 10.05.2021 and 31.05.2021. It is clarified that half of the affected personnel should be relieved by 10.06.2021 and rest before 30.06.2021.
  - b) However, personnel willing to be relieved early on educational ground of wards/extreme compassionate grounds may be allowed to be relieved on or before 10.06.2021.
4. A few personnel from a Unit may opt for early relieving. It is possible that exact matching between such dues-in and dues-out personnel may not be possible and may lead to some challenges. Zonal & Plant DIsG/ Unit Commanders may handle this in a spirit of cooperation keeping in mind the welfare of the personnel given the extraordinary situation being faced.
