Subject:-PROMOTION OF SI/STENO TO THE RANK OF INSP/STENO FOR THE YEAR 2021

The following SIs/Steno are found fit by the DPC held during the year 2021. They are promoted to the rank of Inspector (Steno) on regular basis at Level-7 in the pay Matrix, Rs.44,900 – 1,42,400 (Old pay scale Rs.9300-34800+GP 4600 (PB-2) and posted to the Sectors/Units as shown against their names. They may be adjusted against similar or higher rank. Their promotion will take effect from the date(s) they assume charge as Insp/Steno in the new place of posting.

2. Before promoting them, it should be ensured that they fulfill the following conditions:-
- They are confirmed in the entry grade or in the present rank.
 - They have successfully completed the promotion cadre course of Inspector/Steno.
 - They should have been in medical category Shape-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled SI/Steno after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in para 2 (d) of CISF HQrs letter No.510 dated 01.09.2020, any person who has been declared fit by the DPC subject to attaining of Shape-I medical categorization, shall be promoted only after re-gaining his/her Shape-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2021. In case, he/she does not re-gain Shape-I medical categorization by 31.12.2021, his/her case will be considered afresh by the next DPC.

- iv) No DE/Vigilance/Criminal Proceedings are pending against them.
- v) Promotion should not be given, in case an empanelled SI/Steno is awarded any punishment after the DPC but before his/her actual promotion. If an empanelled SI/Steno is awarded any punishment after the DPC and before his/her actual promotion, the matter may be referred to FHQ (Estt.I Branch) through Sector IsG for deletion of his/her name from the promotion panel as well as cancellation of PCP.
- vi) Promotion should also not be given during the currency of punishment, if any.
- vii) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.


3. In case any of them is un-willing to move on promotion-cum-posting, a certificate should be obtained from the concerned person that he/she is willing to forgo his/her promotion and will not claim promotion and seniority later on and the same may be forwarded to this Directorate (Estt.I Branch) through Sector IsG accordingly.

4. The charge assumption report and Service Order Part-I regarding promotion may be submitted to this HQrs. (Estt-I Branch) by the concerned Units and appointing authority respectively immediately on their assumption of Charge.

5. The promotion of SIs/Steno to the rank of Insp/Steno is subject to Judgement Order dated 26.09.2018 of Hon'ble Supreme court of India in SLP (C) No.30621/2011 and further orders which may be passed by the Hon'ble Supreme Court, as mentioned in DoPT OM No.36012/11/2016-Estt.(Res-I) {Pt-II} dated 15.06.2018.

6. Sector IsG are requested to issue their promotion-cum-posting order and intimate to concerned units/offices under their sector.
