DoP&T vide their OM No. 1/34/2013-IR, dated 30.06.2016, has directed that the Public authorities shall constitute Consultative Committees consisting of office bearers of key stakeholder, association on rotational basis, to have a systematic and regular interaction between the officials of the Public Authorities to advise what information to be uploaded as suo motu.


02. Accordingly, a Consultative Committee of the following Officers is hereby constituted in CISF for the purpose for the year 2018-19:-

Presiding Officer	:	IG, NCR HQrs New Delhi.
Member-I	:	DIG, Ops. CISF HQrs. New Delhi.
Member-II	:	AIG, L&R CISF HQrs. New Delhi.

03. The terms of reference of the Committee are as under:-

- i. To examine, analyze and specify what information with respect to CISF, may be suo-motu disclosed in the public domain i.e. on CISF website.
- ii. Seek opinion of existing CPIOs and 1<sup>st</sup> Appellate Authorities of CISF for such suo motu disclosure.
- iii. Submit it's recommendations on a Quarterly basis, first such report be sent to this Dte. by 05.10.2018 and thereafter by 05.01.2019 and 05.04.2019.
