

विषय: PROMOTION-CUM-POSTING FROM SI/FIRE(LAB) TO THE
RANK OF INSPECTOR/FIRE FOR THE YEAR -2021.

The Sub-Inspector/Fire(Lab) mentioned in Appendix-"A" have been found fit by the DPC for the year 2021. They are promoted to the rank of Inspector/Fire on regular basis at Level 7 in the pay matrix Rs.44900-142400 and posted to the Sectors as shown against their names. Sector IsG will allot them Unit(s) in their Sectors. Their promotion will take effect from the date(s) they assume the charge as Inspector/Fire in their new place of posting.

02. It may be ensured that the empanelled personnel are fulfilling the following conditions before granting them promotion:-

- i) They are confirmed in the entry grade or in the present rank.
- ii) They have successfully completed the promotion cadre course of Inspector/Fire.
- iii) They should have been in medical category Shape-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled SI/Fire after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in para 2(d) of CISF HQrs letter No.687 dated 04.09.2019, any person who has been declared fit by the DPC subject to attaining of Shape-I medical categorization, shall be promoted only after re-gaining his/her Shape-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2021. In case, he/she does not re-gain SHAPE-I medical categorization by 31.12.2021, his/her case will be considered afresh by the next DPC.
- iv) No DE/Vigilance/criminal proceedings are pending/contemplated against them.
- v) Promotion should not be given, in case an empanelled SI/Fire is awarded any punishment after the DPC and before his/her actual promotion. If an empanelled SI/Fire is awarded any punishment after the DPC and before his/her actual promotion, the matter be referred to FHQ (Estt.I Branch) through Sector IsG for deletion of his/her name from the panel as well as cancellation of PCP.
- vi) Promotion should also not be given during the currency of punishment, if any.
- vii) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.

03. In case any of them is unwilling to move on promotion-cum-posting, a certificate should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and seniority later on and the same may be forwarded to this HQrs. (Estt.I Branch) through sector IsG accordingly.


04. The charge assumption report and Service Order Part-I regarding promotion may be submitted to this HQrs. (Estt-I Branch) by the concerned Units and appointing authority respectively on their assumption of Charge.

05. Necessary Service Order Part-I will be published by the appointing authority indicating the PSL Number of SI/Fire (Lab) and date of promotion/assumption of charge in the rank of Inspector/Fire & will invariably forward copies of the S.O. Part-I to this HQ (Estt-I/Estt-II and Tech Branch). In the promotion order, it may be mentioned that Govt. Servant has to exercise the option within one month for fixation of his pay under FR-22.

06. The promotion of SIs/Fire (Lab) to the rank of Insp/Fire is subject to Judgement Order dated 26.09.2018 of Hon'ble Supreme court of India in SLP (C) No.30621/2011 and further orders which may be passed by the Hon'ble Supreme Court, as mentioned in DoPT OM No.36012/11/2016-Estt.(Res-I) {Pt-II} dated 15.06.2018.

07. The posting of personnel earlier earmarked in IST-2020/1st Inter Sector Change (between NS/NCRS) and affected in this panel, may be treated as cancelled.

07. All affected personnel may be relieved immediately and a consolidated compliance report may please be submitted by 15.07.2021.
