

बिषय: PROMOTION-CUM-POSTING FROM ASI/FIRE(LAB)/MM/AE TO THE RANK OF SI/FIRE (LAB) FOR THE YEAR -2021.

The ASI/Fire(Lab)/AE/MM mentioned in Appendix-"A" are promoted to the rank of SI/Fire (Lab) on regular basis in the pay Matrix of Rs.35400-112400 (for GP-4200,level 6) and posted to the Sectors as shown against their names. Sector IsG will allot them Unit(s) in their Sectors. Their promotion will take effect from the date(s) they assume the charge as SI/Fire (Lab) in their new place of posting.

02. Before promoting them, it should be ensured that empanelled personnel are fulfilling the following conditions before granting them promotion:-

- i) They are confirmed in the entry grade or in the present rank.
- ii) They have successfully completed the promotion cadre course of **SI/Fire (Lab)**.
- iii) They should have been in medical category SHAPE-I before being declared FIT for promotion by the DPCs and if there is any deterioration in the medical categorization of the above empanelled ASI/Fire (Lab)/MM/AE, after the DPC and before his/her actual promotion, the promotion will be withheld. Further, as per MHA's directions dated 27.04.2012, incorporated in Para 2 [d] of CISF HQrs, letter No. 521 dated 03.09.2020, any person who has been declared FIT by the DPC subject to attaining of SHAPE-I medical categorization, shall be promoted only after re-gaining his/her SHAPE-I medical categorization, before completion of vacancy year i.e. not later than 31.12.2021. In case he/she do not re-gain SHAPE-I medical categorization by 31.12.2021, his/her case will be considered afresh by the next DPC.
- iv) No Disciplinary/Vigilance/legal proceedings are pending/contemplated against them.
- v) Promotion should not be given, in case an empanelled ASI/Fire (Lab)/MM/AE is awarded any punishment after the DPC and before his/her actual promotion. If an empanelled ASI/Fire(Lab)/MM/AE is awarded any punishment after the DPC and before his/her actual promotion, the matter be referred to FHQ (Estt.I Branch) for deletion of his/her name from the panel as well as cancellation of PCP.
- vi) Promotion should also not be given during currency of punishment if any.




- vii) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.
- viii) In case anyone is unwilling to move on promotion-cum-posting due to his own reason, a certificate should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and for seniority later on and the same may be forwarded to this HQrs (Estt.I Section) through Sector IsG accordingly .

3. The Charge assumption report and Service Order Part-I regarding promotion may be submitted to this HQ (Estt-I/Estt-I) by the concerned Units and appointing authority respectively immediately on their assumption of Charge.

4. The promotion of above ASI/Fire (Lab)/MM/AE is subject to Judgment Order dated 26.09.2018 of Hon'ble Supreme court of India in SLP (C) No. 30621/2011 and further orders which may be passed by the Hon'ble Supreme Court, as mentioned in DoPT OM No. 36012/11/2016-Estt. (Res-I) (Pt-II) dated 15.06.2018.

5. In case, any of the ASI/Fire (Lab)/MM/AE mentioned in Appendix 'A' have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector IsG from the **present place** of posting under intimation to this Dte. However, in case any of the individual has been posted out to another **Sector repeat another Sector**, cases of such personnel may be taken up with this Dte for amendment of PCP.

6. All affected personnel may be relieved immediately and a consolidated compliance report may please be submitted to this Dte by 31 .07.2021.
