
SERVICE ORDER PART-I NO. 140/2021

Subject : PROMOTION-CUM-POSTING FROM CONSTABLE/DCPO TO  
THE RANK OF HC/DCPO FOR THE YEAR 2021.

The Constable/DCPO mentioned in Appendix-"A" are found fit by the DPC held during the year 2021. They are promoted to the rank of Head Constable/DCPO on regular basis in the pay matrix of Rs.25500-81100( for GP-2400, Level-4) and posted to the Sectors as shown against their names. Sector IsG will allot them Units in their Sectors. Their promotion will take effect from the date(s) they assume the charge as Head Constable/DCPO in their new place of posting.

02. It may be ensured that the empanelled personnel are fulfilling the following conditions before granting them promotion:-

- i) They are confirmed in the entry grade or in the present rank.
- ii) They have successfully completed the promotion cadre course of HC/DCPO.
- iii) They should have been in medical category Shape-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled Const/DCPO after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in para 2(d) of CISF HQrs letter No.521 dated 03.09.2020, any person who has been declared fit by the DPC subject to attaining of Shape-I medical categorization, shall be promoted only after re-gaining his/her Shape-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2021. In case, he/she does not re-gain SHAPE-I medical categorization by 31.12.2021, his/her case will be considered afresh by the next DPC.
- iv) No DE/Vigilance/criminal proceedings are pending against them.
- v) Promotion should not be given, in case an empanelled Constable/DCPO is awarded any punishment after the DPC and before his/her actual promotion. If an empanelled Constable/DCPO is awarded any punishment after the DPC and before his/her actual promotion, the matter be referred to FHQ (Estt.I Branch) for deletion of his/her name from the panel as well as cancellation of PCP.
- vi) Promotion should also not be given during the currency of punishment, if any.
- vii) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.


03. In case any of them is un-willing to move on promotion-cum-posting, a certificate should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and seniority later on and the same may be forwarded to this HQrs. (Estt.I Branch) through sector IsG accordingly.

04. In case, any of the Constable/DCPO mentioned above have been posted out to other unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector from the present place of posting under intimation to this Dte. However, in case any of the individual has been posted out to another Sector repeat another Sector, cases of such personnel may be taken up with this Dte for amendment of PCP.

05. The Unit Commandants (Appointing Authority) will issue Unit Service Order Part-I indicating the PSL Number of CT/DCPO and date of promotion/assumption of charge in the rank of HC/DCPO will invariably forward copies of the S.O. Part-I to this HQ (Estt-I/Estt-II and Tech Branch). In the promotion order, it may be mentioned that Govt. Servant has to exercise the option within one month for fixation of his pay under FR-22.

06. **The promotion of Constable/DCPO to the rank of Head Constable/DCPO is subject to Judgement Order dated 26.09.2018 of Hon'ble Supreme court of India in SLP (C) No.30621/2011 and further orders which may be passed by the Hon'ble Supreme Court, as mentioned in DoPT OM No.36012/11/2016-Estt.(Res-I) {Pt-II} dated 15.06.2018.**

07. Compliance report along with charge assumption report and SO PT.I may be forwarded to Estt.I Branch of this HQrs by 20.09.2021 by the concerned Sector IsG.


