1.	Name	Multipurpose Tactical Belt (Web based)
2.	Colour	Black/Camouflage or as prescribed by the user.
3.	Material	 Nylon a) The fabric should be Nylon 6.6 Cordura PU coated with GSM approx 250 or equivalent. The same may be tested by the concerned department if required. Certificate for confirmation of the Cordura classic fabric must be submitted with the tender. b) The fabric must be fire retardant and should not allow any leakage of water. c) The pouches and the belt should be stitched with nylon/polyester thread as required. d) All the pouches should be detachable as per the users needs. e) The buttons used in the belt should be made of brass and powder coated. f) The webbing must be nylon 6 tapes. g) Velcro used in the belt should be Nylon 6-6. It will be tested as per IS 8156. h) Colour fastness of material as per IS/ISO105-C08:2001.

Specifications of Holster/Pouches	 a) The pistol holster must be multipurpose in nature and suitable for holding 9 mm Auto and Glock pistols. b) Pouch for the hand held radio/walkie talkie set must include stretchable elastic to enable carrying of sets/radios of different sizes. c) Pouch for spare battery of the hand held radio. 14 cm (I) x 6 cm (w) x 5 cm (depth). d) Pouch for torch. 14 cm (I) x 6 cm (w) x 5 cm (depth) e) Pouch for foldable Commando knife. 14 cm (I) x 6 cm (w) x 5 cm (depth). f) All pouches to be made of Nylon 6-6 or equivalent. g) Velcro and tich locking system wherever used should be of superior quality.
