Subject :- DEPUTATION TO SPECIAL PROTECTION GROUP (SPG) : REG.

It is proposed to sponsor eligible and willing officers in the rank of DC(Exe) & AC (Exe) for deputation to the post of Senior Security Officer (SSO/GD) in Special Protection Group for a normal tenure period of six years.

2. The ADsG (North/APS/South) and all Sector IsG are therefore requested to forward the nominations of willing and eligible officers alongwith their bio-data as per Annexure-I in respect of DC(Exe) & AC (Exe) who are fulfilling the following criteria as specified by SPG as well as MHA's deputation policy dated 22.11.2016 by **15.11.2021** for necessary action please. :-

1. Must be a Graduate.
2. Below 35 years of age.
3. Clean service records during entire service
4. Must be clear from DE/Vigilance angle.
5. There shall be a minimum cooling off period 03 years between two deputations, out of which, one year should be in the notified hard areas in case of 2nd time deputation. This shall also to apply to the officers who have served on deputation/deployment in UN Peace Keeping Missions abroad and in NSG, SPG & NDRF.
6. Medical category in SHAPE-I.
7. Officers being nominated for deputation will be put through the PET by SPG before induction in SPG. There are 5 events as per details in Annexure-II and the officers will have to qualify all these events.

3. Nominations received with incomplete records or received after due date, will summarily be rejected. Nominal roll in respect of only 07 eligible and willing officers from each sector in the rank of DC(Exe) & AC(Exe) with willingness certificate may be forwarded in Excel format (using Alt+Enter key in single cell) as per Appendix-A to this Directorate within the stipulated time.
