## SUBJECT: PROMOTION-CUM-POSTING FROM CONSTABLE(GD) TO THE RANK OF HEAD CONSTABLE (GD) ON NOTIONAL BASIS - REGARDING

In compliance with Judgment Order dtd 28.02.2013 of Hon'ble High Court of Delhi in WP© No. 361/2013 filed by R. C Mandi Vs UOI and instructions issued by MHA vide letter No.45020/1/2020-Legal-I dtd 10.06.2020, Review DPC for promotion from Constable/GD to HC/GD of Colour Blind personnel was conducted by concerned Sector HQrs. 08 Constables/GD as mentioned in **Appendix-A** have been found FIT for promotion to the rank of HC/GD on notional basis from the date their junior have assumed the charge of HC/GD (as mentioned against each) and as such their Sector are allotted against their name on PCP.

<u>Note</u>: The promotion in respect of S.No. 02 & 08 of Appendix-A is subject to judgment Order dtd 26.09.2018 of Hon'ble Supreme Court of India in SLP (C) No 30621/2011 and further orders which may be passed by the Hon'ble Supreme Court as mentioned in DoPT OM No 36012/11/2016-Estt.(Res-1){Pt-II} dtd 15.06.2018.

- 02. It may be ensured that the empaneled personnel are fulfilling the following conditions before granting them promotion:
  - a) They are confirmed in the entry grade or in the present rank.
  - b) They have successfully completed the Promotion Cadre Course of Const/GD to HC/GD.
  - c) In case of SC / ST candidates, a certificate to that effect issued by the competent authority is available in their service documents.
  - d) In case any of them is unwilling to move on promotion-cum-posting, a certificate should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and seniority later on and same, may be forward to this HQrs(Estt.I) branch accordingly.
  - e) The charge assumption report and service order Part-I regarding promotion may be submitted to this Hqr (Estt-I branch) by the concerned units and appointing authority respectively, immediately on assumption of their charge.
- 03. In case, any of the Constable/GD mentioned in "Appendix-A" have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector from the present place of posting under intimation to the Dte. However, in case any of the individual has been posted out to another Sector repeat another Sector, case of such personnel may be taken up with this Dte for amendment of PCP.
