 4. This issues with the approval of Competent Authority.

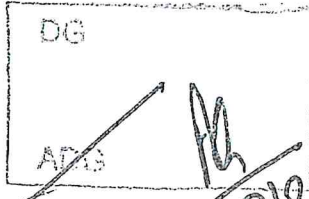
