

बिषय: PROMOTION-CUM-POSTING FROM SI(FIRE/LAB/MECH) TO THE RANK OF INSPECTOR/FIRE FOR THE YEAR -2022.

The Sub-Inspector (Fire/Lab/Mech) mentioned in Appendix-"A" are found fit by the regular DPC – 2022 and empanelled for promotion to the rank of Inspector/Fire on regular basis at Level-7 in the pay matrix of Rs.44,900-1,42,400 {Old pay scale of Rs. 9300-34800+ GP 4600 (PB-2)} and posted to the Sectors as shown against their names. Sector IsG will allot them Unit(s) in their Sectors. Their promotion will take effect from the date(s) they assume the charge as Inspector/Fire in the new place of posting.

02. Before promoting them, it should be ensured that they fulfill the following conditions:-

- i) They are confirmed in the entry grade or in the present rank.
- ii) They have successfully completed the promotion cadre course of Inspector/Fire.
- iii) They should have been in medical category Shape-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled Sub-Inspector (Fire/Lab/Mech) after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in para 2(d) of CISF HQs letter No. 675 dated 03.09.2021, any person who has been declared fit by the DPC subject to attaining of Shape-I medical categorization, shall be promoted only after re-gaining his/her Shape-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2022. In case, he/she does not re-gain SHAPE-I medical categorization by 31.12.2022, his/her case will be considered afresh by the next DPC.
- iv) No DE/Vigilance/criminal proceedings are pending against them.
- v) Promotion should not be given, in case an empanelled SI/Fire is awarded any punishment after the DPC and before his/her actual promotion. If an empanelled Sub-Inspector (Fire/Lab/Mech) is awarded any punishment after the DPC and before his/her actual promotion, the matter may be referred to FHQ (Estt.I Branch) through Sector IsG for deletion of his/her name from the panel as well as cancellation of PCP.
- vi) Promotion should also not be given during the currency of punishment, if any.
- vii) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.

03. In case any of them is un-willing to move on promotion-cum-posting, a certificate should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and seniority later on and the same may be forwarded to this HQrs. (Estt.I Branch) through sector IsG accordingly.


04. The promotion of Sub-Inspectors (Fire/Lab/Mech) to the rank of Insp/Fire is subject to Judgement Order dated 26.09.2018 of Hon'ble Supreme court of India in SLP (C) No.30621/2011 and further orders which may be passed by the Hon'ble Supreme Court, as mentioned in DoPT OM No.36012/11/2016-Estt.(Res-I) {Pt-II} dated 15.06.2018.

05. In case, any of the SI/Fire/Mech mentioned above have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector from the present place of posting under intimation to this Dte. However, in case any of the individual has been posted out to another Sector repeat another Sector, case of such personnel may be taken up with this Dte. for amendment of PCP.

06. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of Insp/Fire in the unit. The charge assumption report and Service Order Part-I regarding promotion may be submitted to this HQrs (Estt-I Branch) by the concerned units and appointing authority respectively immediately on their assumption of charge.

07. All concerned sectors are requested to ensure compliance as under:-

- a) Allotment of Zones/Units, assumption of charge etc. to be updated on "Posting Order Monitoring System" software as per instructions issued vide this Dte. Msg No. (5450) dated 12.10.2021.
- b) Allotment of Units by the Sector by : 25.08.2022
- c) Relieving of personnel on PCP by : 31.08.2022
- d) Date of submission of relieving compliance to Estt-II/FHQ by : 05.09.2022
