**SERVICE ORDER PART-I NO. 141/2022**

**SUBJECT: PROMOTION CUM POSTING FROM CONSTABLE/TM (ELECTRICIAN) TO THE RANK OF HEAD CONSTABLE/TM (ELECTRICIAN) ON REGULAR BASIS FOR THE YEAR-2022.**

The Constable/TM (**ELECTRICIAN**) mentioned at below are promoted to the rank of Head Constable/TM (**ELECTRICIAN**) on regular basis in the pay matrix of Rs. 25500-81100 (for GP-2400, level-4) and posted to the Sectors/Units as shown against their names. His promotion will take effect from the date(s) he assume charge of Head Constable/TM (**ELECTRICIAN**) in the new place of posting:-



02. Before promoting him, it should be ensured that they fulfill the following conditions:

- He is confirmed in the entry grade or in the present rank.
- He has successfully completed the Promotion Cadre Course of HC/TM (**ELECTRICIAN**).
- He should have been in medical category Shape-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled Constable/TM (**ELECTRICIAN**) after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in para 2(d) of CISF HQrs letter No. 674 dated 03.09.2021, any person who has been declared fit by the DPC subject to attaining of Shape-I medical categorization, shall be promoted only after re-gaining his/her Shape-1 medical categorization, before completion of the vacancy year i.e not later than **31.12.2022**. In case, he/she does not regain SHAPE-1 medical categorization by **31.12.2022**, his/her case will be considered afresh by the next DPC.
- No DE/Vigilance/criminal proceedings is pending against him,.
- Promotion should not be given, in case an empanelled Constable/TM (**ELECTRICIAN**) is awarded any punishment after the DPC and before his / her actual promotion. If an empanelled Constable/TM (**ELECTRICIAN**) is awarded any punishment after the DPC and before his/her actual promotion, the matter may be referred to FHQrs (**Estt.I Branch**) through sector IsG for deletion of his/her name from the promotion panel as well as cancellation of his PCP.
- Promotion should also not be given during the currency of punishment, if any.
- In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.

- h. In case any of them is unwilling to move on promotion-cum-posting, a certificate should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and seniority later on and the same may be forwarded to this HQrs (**Estt.I branch**) through sector IsG accordingly.
- i. The charge assumption report and Service Order Part-I regarding promotion may be submitted to this HQrs.(Estt-I Branch) by the concerned Units and appointing authority respectively immediately on their assumption of Charge.
- j. **The promotion of Const/TM (ELECTRICIAN) to the rank of HC/TM (ELECTRICIAN) is subject to Judgement Order dated 26.09.2018 of Hon'ble Supreme Court of India in SLP (C) No. 30621/2011 and further orders which may be passed by the Hon'ble Supreme Court as mentioned in the DoPT OM No.F-No.36012/11/2016-/Estt(Res-I)(Pt-II) dated 15.06.2018.**
3. In case, any of the Constable/TM (**ELECTRICIAN**) mentioned above have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector from the present place of posting under intimation to the Dte. However, in case any of the individual has been posted out to another Sector repeat another Sector, case of such personnel may be taken up with this Dte for amendment of PCP.
4. **All concerned sectors are requested to ensure compliance as under:-**
- a) Allotment of Zones/Units, assumption of charge etc. to be updated on "**Posting order monitoring system**" software as per instructions issued vide this Dte Msg. No. (5450) dtd 12.10.2021.
- b) Allotment of unit by the Sector/Zone by :- **20.09.2022**
- c) Relieving of personnel on PCP by :- **27.09.2022**
- d) Date of submission of relieving compliance to Estt-I/FHQ by :- **10.10.2022**
5. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of Head Constable/TM (**ELECTRICIAN**) in the unit.
6. Compliance report along with charge assumption report will be forwarded to Estt-I Branch of this HQrs.
