विषय:- PROMOTION-CUM-POSTING FROM CONSTABLE/FIRE TO THE RANK OF HEAD
CONSTABLE/FIRE FOR THE YEAR-2022 : REG

Please refer to CISF HQrs S.O Part-I No.207/2022 issued vide letter No.E-31014/CT(F)-HC(F)/Estt.II/PCP/2022/5247 dated 08.12.2022 on the subject matter.

02. The **Constables/Fire** mentioned in Appendix-A are found fit by the regular DPC-2022 and empanelled for promotion to the rank of **Head Constable/Fire** on regular basis in the pay matrix of Rs.25500-81100 (for GP-2400, level-4) and posted to the Units as shown against their names. Their promotion will take effect from the date(s) they assume charge of **HC/Fire** at the new place of posting.

03. Before promoting them, it should be ensured that empanelled personnel are fulfilling the following conditions:-


- i) They are confirmed in the entry grade or in the present rank.
- ii) They have successfully completed the promotion cadre course of **HC/Fire**.
- iii) They should have been in medical category SHAPE-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of the empanelled **Constable/Fire** after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012 incorporated in para 2(d) of CISF HQrs letter No. 675 dated 03.09.2021 any person who has been declared fit by the DPC subject to attaining of SHAPE-I medical categorization, shall be promoted only after re-gaining his/her SHAPE-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2022. In case, he/she does not re-gain SHAPE-I medical categorization by 31.12.2022, his/her case will be considered afresh by the next DPC.
- iv) No DE/Vigilance/ Criminal Proceeding are pending against them.
- v) Promotion should not be given, in case an empanelled **Constables/Fire** is awarded any punishment after the DPC and before his/her actual promotion. If an empanelled Constable/Fire is awarded any punishment after the DPC and before his/her actual promotion, the matter may be referred to FHQ (Estt.-I Branch) for deletion of his/her name from the panel as well as cancellation of PCP through this HQrs.
- vi) Promotion should also not be given during the currency of punishment, if any
- vii) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.

04 In case anyone is un-willing to move on promotion-cum-posting, a certificate should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and seniority later on and the same may be forwarded to this HQrs., accordingly.

05. The promotion of **Constables/Fire to the rank of HC/Fire** is subject to Judgement Order dated 26.09.2018 of Hon'ble Supreme court of India in SLP(C) No. 30621/2011 and further orders which may be passed by the Hon'ble Supreme Court, as mentioned in DoPT OM No. 36012/11/2016-Estt.(Res-I) {Pt-II} dated 15.06.2018

06. In case, any of the **Constables/Fire** mentioned in **Appendix-A** have been posted out to another Unit in this Sector, such case may be taken up with this Sector HQrs for amendment of promotion-cum-posting. However, in case any of the individual has been posted out to another Sector repeat another sector, cases of such personnel may be taken up with FHQrs for amendment of PCP.
08. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of **HC/Fire** in the Unit. The Charge assumption report and Service Order Part-I regarding promotion may be forwarded to Estt.I branch of FHQ under intimation to this HQrs by the concerned Units and appointing authority respectively immediately on their assumption of charge.
09. Above mentioned personnel may be relieved on PCP by **18.12.2022** and compliance report (updating on Posting Order Monitoring System) along with charge assumption report will be forwarded to Estt.I Branch of FHQ latest by **23.12.2022 under intimation to this Sector HQrs.**
