- Applications of eligible candidates who are posted in the units under the administrative 4: control of DIsG Plant or DIsG DAE or DOS or Airports or BNs or GBS or SSG or HQRs or in Training Institutions will be forwarded directly to the respective Zonal DIsG (Application Receiving Centres) mentioned in Para-3 above by the respective Unit Commanders instead of routing the same through their Zonal DIsG. Additional 10% candidates over and above the number of vacancies from amongst the qualified candidates in Written Examination and PET, in order of merit shall be called for medical examination to take care of those candidates who either remain absent or fail in DME/RME. The candidates declared fit in DME and subsequent RME will not have a right of final selection, as final selection will be merit based depending upon the number of vacancies. Hence any claim in this regard later on will not be entertained.

(vi) Final Selection

Name of candidates will be placed in the merit list subject to the obtaining minimum qualifying marks in each subject as well as the aggregate marks (minimum 50% aggregate marks out of a total of 200 marks for General category i.e. 100 marks and candidate belonging to SC/ST category have secured minimum 45% aggregate marks i.e., 90 marks). Final selection of candidates will be made according to availability of vacancies and subject to their being declared 'FIT' in the Detailed Medical Examination or Review medical examination as the case may be.

8. LAST DATE OF RECEIPT OF APPLICATION

All eligible departmental candidates may submit their application as per Appendix-A along with Appendix-B, B-1 & B-2 duly filled to their respective Unit Commanders by 05.02.2023 i.e., last date for receipt of applications by the Unit Commanders. All received applications should be counter signed by a GO of the unit after verification of bio-data of the individual from service records. All applications should be forwarded to concerned DIG duly signed by the Unit Commander in prescribed format as per Appendix-A-1. Last date of receipt of the above applications by the respective DISG (Application Receiving Centre) as mentioned in Para-3 above shall be 12.02.2023. The Unit Commanders while forwarding the applications will ensure that the following documents are duly attested by a Gazetted Officer:

- a) Certificate in support of belonging to SC/ST & Hill areas on the format as prescribed in Appendix "C" & "D" circulated vide this Directorate letter No.E-32017/3/06/Rectt/934 dated 25.05.2006.
- b) Matriculation certificate in support of date of birth
- c) Graduation degree certificate from recognized University in support of educational qualification.

Note: If there is any change/amendment in the eligibility condition, the same will be published on CISF website. Candidates may check the same from the website or from the Office of Sector IsG/Zonal DIsG. Mere submission of the application does not give the candidate right to be considered unless he meets the eligibility requirements prescribed at the time of issue of admit cards.

Applications received after 05.02.2023 i.e the last date of receipt of application in the concerned unit will not be accepted and summarily be rejected.

10. RESPONSIBILITY OF THE UNIT COMMANDERS

Unit Commanders will personally ensure that:-

- a) A copy of this notification is circulated to all Coy Commanders and is also affixed on the notice board and contents of the notification are also brought to the notice of all eligible personnel.
- b) Unit Commander should ensure that the personnel on Election duty, Temporary duty, attachment etc should be informed well in time. Forwarding of applications submitted by the individuals is the responsibility of concerned unit Commanders.
- c) It should be ensured that applications in respect of all eligible personnel of the unit have been obtained in the prescribed format and forwarded to the <u>concerned Zonal DIsG</u> (ARCs) (i.e., DIG(NZ-I) New Delhi, DIG(SZ-1) Chennai, DIG(WZ) Mumbai, DIG/RRC 2ND RB Ranchi, DIG(SEZ-1) Kolkata, DIG (NCR) New Delhi, DIG (CZ) Bhilai and DIG (NEZ-1) Guwahati as the case may be) so as to reach them on or before 12.02.2023.
- d) Latest colour passport size photograph duly dated (i.e. not more than three months old from the date of publication of this Notification) of the candidate in uniform without cap should be affixed on the right corner of the application form for the post of ASI/Exe (LDCE)-2022 i.e., Appendix-A.
- e) It should be ensured that application form is filled correctly and the candidate is fulfilling the eligibility criteria as prescribed in Para-2 and 6 above. Particulars filled in the application form should be verified from the record held in the unit and the same may be countersigned by a GO of the Unit. There should not be any column left without verification, which may lead to complications at a later stage.



- f) It should be ensured that applications are accompanied with Photostat copies of required certificates, duly attested.
- g) It should be ensured that all columns meant for the candidates vide Appendix-A, B, B-1 & B-2 are filled by the candidates and countersigned by a GO of the unit at appropriate place before the same is forwarded to the DIsG.
- h) An application with incomplete / wrong / false information / misrepresentation of facts / left unsigned / without a self-attested photograph pasted at the appropriate place shall be summarily rejected.
- i) Eligible personnel of the unit may be informed that <u>only three chances</u> are available for appearing in the LDCE.
- j) Service documents of the individuals, whose applications are sent to the application receiving authority, may be updated including Annual Remarks up to 31.12.2022 and SHAPE-1 certificate for the year 2022 and sent to DIG, CISF Unit, SSG, Noida (UP) by 20.02.2023 for scrutiny of documents.
- k) In case any candidate who is having clean record of service as on the date of submission of application, is awarded any major or minor punishment subsequently in between the date of submission of application and the date of joining to the post of ASI/Exe(LDCE), his/her candidature will be rejected forthwith.
- It will be the responsibility of the Unit Commander not to forward any application of candidate who have not maintained 'Good' ACRs for the last five years and who have been awarded any major or minor punishment(s) during his/her entire service till the date of forwarding his/her application. Further, in case, a candidate is awarded any major or minor punishment after submission of his/her application, it will be the responsibility of the concerned Unit Commander to inform the facts to the application receiving Zonal DIsG (ARCs) and to not relieve such candidate for attending the Written Exam/PST/PET/Medical whenever he/she is called for the same. Information to this affect may also be sent to this Dte. The Zonal DIsG (ARCs) concerned will dispose of such cases at their end as per instructions issued in this Notification at Para-6(d) and Para-10(k).
- m) In case any candidate who is holding the post in Executive cadre on the date of submission of application and subsequently accepts appointment to any other cadre of the Force viz., Fire or Ministerial, etc., he will become ineligible to compete in this LDCE and his candidature will be rejected.
- The applications of the candidates, who have availed 03 chances including 2021 recruitment, need not to be forwarded for 2022 recruitment.

11. ACTION TO BE TAKEN BY THE ZONAL DISG (ARCs):

Immediately on receipt of an application, it will be checked thoroughly and it must be ensured that the candidate fulfills the prescribed eligibility criteria as mentioned above. Number of applications found in order and accepted will be intimated to this Directorate as well as DIG/CISF SSG Gr. Noida by 20.02.2023. While forwarding the applications of the candidates to DIG/CISF SSG Gr. Noida, a list of candidates in the
