UPSC has informed that Personality Tests of the remaining 13 candidates of the CISF (AC/Exe) Limited Departmental Competitive Exam, 2022 have been re-scheduled **on 27.03.2023 (01 day)** in the Commission. Accordingly, the PT Schedule has been made available on the Commission's website.

2. Further, UPSC has informed that the e-Summon Letters of these candidates will be made available shortly on Commission's website. All the candidates may be advised to download the same and adhere to the instructions given in e-summon letter for appearing in Personality Test. **A list of 13 candidates alongwith a copy of Important Notice of UPSC related to CISF AC (Exe) LDCE, 2022 Personality test are also enclosed herewith.** It is pertinent to mention that in pursuance to the order dated 03.02.2023 passed by the Hon'ble Delhi High Court in the matter of WP(C) No.5877/2022 (Diwakar Pande & Ors. Vs. UoI & Ors), the Commission has decided to resume the Interview/PT Board for the remaining 13 candidates of the CISF AC(Exe) LDCE, 2022 subject to the outcome of the Writ Petition.

3. Hence, all the affected candidates (as per Appendix-'A') under your jurisdiction may kindly be directed to adhere to the instructions as given in their e-summon letter for appearing in Personality Test/Interview. It is also added that there is a possibility that some of them might have been transferred to other unit under IZT/IUT. In that case his present Unit Commander may be asked for doing the needful.

4. It is further informed that –

1. Uniform for Interview will be working uniform. If some of the candidates are on deputation with NSG/SPG they will be in the uniform of respective organisation. The candidates must carry with them the e-summon already issued to them by the UPSC

and Departmental Identity Card failing which they will not be allowed to appear in the personality test/Interview.

2. Bring two passport size photographs in uniform taken recently.
3. The candidates should come prepared to stay for 1 or 2 days as per their own arrangements.
4. No TA-DA/Journey expenses will be allowed to the candidates for attending the Interview.

The Personality Test/Interview of the CISF AC (Exe) LDCE, 2022 had commenced from 31.10.2022. However, the same was stopped w.e.f. 03.11.2022 (AN) due to certain development in WP (C) No. 5877/2022 (Diwakar Pande & Ors. Vs. UoI & Ors.) before the Hon'ble Delhi High Court. Subsequently, the Hon'ble Court passed the following order on 03.02.2023:-

*"we hereby modify the Order dated 07.10.2022 to the extent that any selection on the post of Assistant Commandant in the CISF shall be subject to outcome of the present petition."*

2. In view of the above order, the Commission has decided to resume the Interview/PT Board for the remaining 13 candidates of the CISF AC (Exe) LDCE, 2022 subject to the outcome of the Writ Petition. **The e-Summon Letters** of these candidates will be made available shortly, which may be downloaded from the Commission's Website <https://www.upsconline.in>. The candidates are advised to download their e-Summon Letter along with all its enclosures and take a printout thereof and adhere to the instructions given in e-Summon letter for appearing in the Personality Test.
