SERVICE ORDER PART-I NO. 114 /2023

**SUBJECT: PROMOTION-CUM-POSTING FROM ASI/CLK TO THE
RANK OF SI/MIN FOR THE YEAR -2023.**

The ASIs/Clk mentioned in Appendix-"A", are found fit by the regular DPC-2023 and empanelled for promotion to the rank of Sub Inspector /Min on regular basis at level-6 in the Pay Matrix of Rs.35,400/- - 1,12,400/- (Old pay scale of Rs.9300-34800 + GP 4200 (PB-2) and posted to the Sectors as shown against their names. They may be adjusted against similar rank. Their promotion will take effect from the date(s) they assume charge of **Sub-Inspector/Min** in the new place of posting.

02. **Before promoting them, it should be ensured that they fulfill the following conditions:-**

- i. They are confirmed in the entry grade or in the present rank.
- ii. They have successfully completed the promotion cadre course of Sub Inspector/Min.
- iii. They should have been in medical category Shape-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled ASI/Clk after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in para 2 (d) of CISF HQrs letter No.591 dated 06.09.2022, any person who has been declared fit by the DPC subject to attaining of Shape-I medical categorization, shall be promoted only after re-gaining his/her Shape-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2023. In case, he/she does not re-gain Shape-I medical categorization by 31.12.2023, his/her case will be considered afresh by the next DPC.
- iv. No DE/Vigilance/Criminal proceedings are pending against them.
- v. Promotion should not be given, in case an empanelled ASI/Clk is awarded any punishment after the DPC but before his/her actual promotion. If an empanelled ASI/Clk is awarded any punishment after the DPC and before his/her actual promotion, the matter may be referred to FHQ (Estt.I Branch) through Sector IsG for deletion of his/her name from the promotion panel as well as cancellation of PCP.
- vi. Promotion should also not be given during the currency of punishment, if any.
- vii. In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.
- viii. It may also be mentioned that on promotion, they shall be on probation for a period of two years in the rank of SI/Min from the date of assumption of charge and their promotion will be subject to satisfactory completion of their probation period.

03. In case any of them is un-willing to move on promotion-cum-posting, a certificate should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and seniority later on and the same may be forwarded to this HQrs. (Estt.I Branch) through Sector IsG accordingly.

05. The promotion of ASI/Clk to the rank of SI/Min against the year 2023 is subject to:-


- 1) Order passed on 28.01.2022 by the Hon'ble Supreme Court in the case of Jarnail Singh and Ors. V. Lachmi Narain Gupta and Ors.(Civil Appeal No.629 of 2022 arising out of SLP (C) No.30621 of 2011) and other connected matters as mentioned in DoPT OM No.36012/16/2019-Estt.(Res.) dated 12.04.2022.

06. In case, any of the ASI/Clk mentioned above have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector from the present place of posting under intimation to this Dte. However, in case any of the individual has been posted out to another Sector repeat another Sector, case of such personnel may be taken up with this Dte for amendment of PCP.

07. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of Sub-Inspector/Min in the Unit.

08. All concerned sectors are requested to ensure compliance as under:-

- a) Allotment of Zones/Units, assumption of charge etc. to be updated on "Posting order monitoring system" software as per instruction issued vide this Dte Msg. No. (5450) dated: 12.10.2021.
- b) Allotment of unit by the Sector/Zone by : 12 /09/2023
- c) Relieving of personnel on PCP by : 18 /09/2023
- d) Date of submission of relieving compliance to Estt-I/FHQ by : 25/09/2023
