2. Vide letter under reference Secretary, WARB (MHA) has intimated that the National Scholarship Portal for the Prime Minister Scholarship Scheme (PMSS) for the wards of CAPFs & Assam Rifles personnel for the academic year 2023-24 has been decided to be opened w.e.f. 1st October, 2023 to 31st December, 2023 (For Registration / Filling of online application by the applicant on National Scholarship Portal 2.0 (NSP 2.0) ([www.scholarships.gov.in](http://www.scholarships.gov.in))). The PMSS guidelines for the academic year 2023-24 is enclosed herewith for information and further necessary action. Further, the applicants may also be advised to liaise with their concerned College/Institution/University after successful submission of their applications on National Scholarship Portal to get their applications verified on or before 15th January, 2024.

3. The schedule of activities/timelines for opening of Portal for the Academic Year 2023-24 for WARB MHA Scheme under Fresh & Renewal Category is appended below:-

4. Any request for extension of last date for submission of the application will not be considered. As per PMSS guidelines, only online application are to be accepted and no application after lapse of due date will be entertained. As per the National Scholarships Portal (NSP)/PMSS guidelines, candidates whose online application have not been verified online by the concerned Institutes/Nodal Officer are not eligible for scholarship under fresh/renewal category.

5. The major points of revised guideline are as under :-

- i) Registration for the Prime Minister's Scholarship Scheme (PMSS) for CAPFs, Assam Rifles & State Police Personnel to be opened w.e.f. 01.10.2023 to 31.12.2023 on National Scholarships Portal (NSP)2.0 version for registration/filling of online applications by the applicant.
- ii) Amount of Scholarship is Rs. 36,000/- for Girls Rs. 30,000/- for Boys.
- iii) Detailed/Revised guidelines/requisite documents/prescribed proforma as well as process flow for registration/submission of online application under PMSS are available on NSP 2.0.
- iv) Eligible /willing fresh applicants may be directed to register in the fresh category. Renewal applicants may apply in the renewal category through previous user ID and password on NSP for submission of online application under PMSS. The proposed last date for submission of the application has been intimated as 31<sup>th</sup> December 2023.


**Important Instructions :-**

- a) It will be the sole responsibility of the applicant to make sure that he/she is eligible to apply and fulfill all the conditions prescribed for the scholarship.
- b) If in-eligibility of the applicant is detected at any stage, before or after the applying for scholarship scheme, or during at any stage by verification by authorities, his/her scholarship will be cancelled without any notice. Disciplinary action will be taken against him/her, further he/she will be blacklisted to opt for scholarship sponsored by Central Govt. for a period of five years.
- c) Incomplete application form and failure to attach the requisite documents will lead to rejection of application.
- d) All the requisite information should be clearly mentioned in the respective column. The information once generated on the part of applicant, no change/amendment will be accepted.
- e) Mobile number and Email address of applicant's or wards of CAPFs, AR & State Police Personnel is mandatory so as to inform the candidate of any discrepancies or development through SMS and Email.
- f) The correct Force type may be selected in Force Column "Central Industrial Security Force (CISF)", while filling up the form.
- g) Please ensure that the application verification process has been completed, as check status facility is already available in each ward account in NSP and SMS is received in the respective registered mobile No .
- h) The applicants will also ensure that while submitting their online application the correct Gender in the application, whichever is applicable is filled up.
- i) Renewal applicant will also upload their respective Category Certificate.
