 - iii) Maximum 42 years of age.
 - iv) Should be clear from Disc/Vigilance angle
 - v) Clean records of service.
 - vi) Should be medically fit (SHAPE-I).
- vii) Officers who attended PIT/Interview for deputation to SPG in the past can be re-nominated only after expiry of minimum 03 years period.

- All Sector IsG are, therefore, requested to forward the nominations of willing and eligible officers in the rank of Commandant & Dy. Commandant alongwith bio-data as per <u>Annexure-I</u> to this Directorate by <u>01.12.2023</u> repeat <u>01.12.2023</u> positively.
