SERVICE ORDER PART-I NO. 194 / 2023

Sub:- **PROMOTION-CUM-POSTING FROM HC/MIN TO THE RANK OF ASI/CLK FOR THE YEAR-2023 (PANEL STRENGTH - 102).**

The HC/Min mentioned in Appendix-A are found fit by the regular DPC for the year 2023. They are promoted to the rank of Asstt Sub-Inspector (Clk) on regular basis in the pay matrix of Rs.29,200-92,300 (For GP-2800, Level- 5) and posted to the Sectors/Units as shown against their names. Their promotion will take effect from the date(s) they assume charge as ASI/Clk in the new place of posting.

2. Before promoting them, it should be ensured that they fulfill the following conditions:

- i) They are confirmed in the entry grade or in the present rank.
- ii) They have successfully completed the promotion cadre course of ASI/Clk.
- iii) They should have been in medical category Shape-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled HC/Min after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in para 2 (d) of CISF HQrs letter No.(591) dated 06.09.2022, any person who has been declared fit by the DPC subject to attaining of Shape-I medical categorization, shall be promoted only after re-gaining his/her Shape-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2023. In case, he/she does not re-gain Shape-I medical categorization by 31.12.2023, his/her case will be considered afresh by the next DPC.
- iv) No DE/Vigilance/Criminal Proceedings are pending against them.
- v) Promotion should not be given, in case an empanelled HC/Min is awarded any punishment after the DPC and before his/her actual promotion. If an empanelled HC/Min is awarded any punishment after the DPC and before his/her actual promotion, the matter may be referred to FHQ (Estt.I Branch) through sector IsG for deletion of his/her name from the promotion panel as well as cancellation of PCP.
- vi) Promotion should also not be given during the currency of punishment, if any.
- vii) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.

3. In case any of them is un-willing to move on promotion-cum-posting, a certificate should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and seniority later on and the same may be forwarded to this HQrs. (Estt.I Branch) through sector IsG accordingly.

4. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of ASI/Clk. The charge assumption report and Service Order Part-I regarding promotion may be submitted to this HQrs. (Estt-I Branch) by the concerned Units and appointing authority respectively immediately on their assumption of Charge.


5. **The promotion of HC/Clk to the rank of ASI/Clk against the year 2023 is subject to:-**

Order passed on 28.01.2022 by the Hon'ble Supreme Court in the case of Jarnail Singh and Ors. V. Lachhmi Narain Gupta and Ors.(Civil Appeal No.629 of 2022 arising out of SLP (C) No.30621 of 2011) and other connected matters as mentioned in DoPT OM No.36012/16/2019-Esttt.(Res.) dated 12.04.2022.

6. **In case, any of the HC/Min mentioned above have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector from the present place of posting under intimation to this Dte. However, in case any of the individual has been posted out to another Sector repeat another Sector, case of such personnel may be taken up with this Dte for amendment of PCP.**

7. All concerned sectors are requested to ensure compliance as under :-

- a) Allotment of zones/Units, assumption of charge etc to be updated on "**Posting Order Monitoring System**" software as per instructions issued vide this Dte. Msg No.(5450) dated 12.10.2021.
- b) Allotment of Unit by the Sector/Zone : 26.12.2023
- c) Relieving of Personnel on PCP by : 30.12.2023
- d) Date of submission of relieving compliance to Estt.II/FHQrs: 05.01.2024


