SERVICE ORDER PART-I NO. 198 / 2023

Subject:- PROMOTION-CUM-POSTING FROM HC(GD) TO THE RANK OF ASI/EXE FOR THE YEAR -2023

The HCs/(GD) mentioned in Appendix -'A' are found fit by the DPC held during the year 2023. They are promoted to the rank of Assistant Sub Inspector (Exe) on regular basis in the pay level 5 in the new Pay Matrix 29200-92300, and posted to the Sectors as shown against their names. Their promotion will take effect from the date(s) they assume charge as ASI/Exe in the new place of posting.

2. Before promoting them, it should be ensured that they fulfill the following conditions:-

- i) They are confirmed in the entry grade or in the present rank.
- ii) They have successfully completed the promotion cadre course of ASI/Exe.
- iii) They should have been in medical category SHAPE-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled HCs/GD after the DPC and before actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in para 2(d) of CISF HQrs letter No. 591 dated 06.09.2022 any person who has been declared fit by the DPC subject to attaining of Shape-I medical categorization, shall be promoted only after re-gaining his/her SHAPE-I medical categorization, before completion of the vacancy year i.e. not later than **31.12.2023**. In case, does not re-gain SHAPE-I medical categorization by **31.12.2023**, their case will be considered afresh by the next DPC.
- iv) No DE / Vigilance / Criminal proceedings are pending against them. Promotion should not be given during currency of punishment.
- v) Promotion should not be given, in case an empanelled HCs/GD is awarded any punishment after the DPC and before actual promotion. If an empanelled HCs/GD is awarded any punishment after the DPC and before actual promotion, the matter be referred to FHQ. (Estt.I Branch) through Sector IsG for deletion of name from the panel as well as cancellation of promotion.
- vi) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.
- vii) Before relieving/ promoting the HCs/GD, the Seniority List may be tallied with service document.

3. In case any of them is un-willing to move on promotion-cum-posting, an undertaking in format (duly countersigned by the authority concerned) citing that he is willing to forgo promotion, will not claim promotion and seniority later on, should be obtained from person concerned and sent to this HQrs. (Estt.I Branch) through Sector IsG accordingly.

4. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge to the post of ASI/Exe in the unit. The charge assumption report and Service Order Part-I regarding promotion may be submitted to this HQrs. (Estt-I Branch) by the concerned Units and appointing authority respectively immediately on their promotion.

5. The promotion of HCs/GD to the rank of ASI/Exe is subject to Judgement Order dated 28.01.2022 by the Hon'ble Supreme court of India in the case of Jarnail Singh and Ors V.Lachhmi Narain Gupta and Ors, (Civil Appeal No. 629 of 2022) arising out of SLP (C) No. 30621 of 2011 and other connected matters as mentioned in DoPT OM No. 36012/16/2019-Estt (Res.) dated 12.04.2022.

6. In case, any of the HC/GD mentioned above have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector from the present place of posting under intimation to this Dte. However, in case any of the individual has been posted out to another Sector repeat another Sector, case of such personnel may be taken up with this Dte for amendment of PCP

7. All concerned sectors are requested to ensure allotment of Zones/Units to the affected personnel and their relieve on PCP at the earliest. Their allotment of Zones/Units, assumption of charge etc. to be updated on "Posting order monitoring System" software as per instruction issued vide this Dte. Msg. No. (5450) dated 12.10.2021.
