बिषय: PROMOTION-CUM-POSTING FROM SI (FIRE/LAB) AND SI (MECH/FIRE)
TO THE RANK OF INSPECTOR/FIRE FOR THE YEAR 2024

The Sub Inspector (Fire/Lab) and Sub Inspector (Mech/Fire) as mentioned in **Appendix-“A”** are found fit by the regular DPC-2024 and empanelled for promotion to the rank of Inspector/Fire on regular basis at Level-7 in the pay matrix of Rs. 44,900-1,42,400 {Old pay scale of Rs. 9300-34800+GP 4600 (PB-2)} and posted to the Sectors as shown against their names. Sector IsG will allot them Unit(s) in their Sectors. Their promotion will take effect from the date(s) they assume the charge as Inspector/Fire at the new place of posting.

02. Before promoting them, it should be ensured that they fulfill the following conditions:-

- i) They are confirmed in the entry grade or in the present rank.
- ii) They have successfully completed the promotion cadre course of Inspector/Fire.
- iii) They should have been in medical category Shape-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled Sub Inspector (Fire/Lab/Mech) after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in para 2(d) of CISF HQrs letter No.642 dated 05.09.2023, any person who has been declared fit by the DPC subject to attaining of Shape-I medical categorization, shall be promoted only after re-gaining his/her Shape-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2024. In case, he/she does not re-gain SHAPE-I medical categorization by 31.12.2024, his/her case will be considered afresh by the next DPC.
- iv) No DE/Vigilance/criminal proceedings are pending against them.
- v) Promotion should not be given, in case an empanelled SI(Fire/Lab/Mech) is awarded any punishment after the DPC but before his/her actual promotion. If an empanelled SI(Fire/Lab/Mech) is awarded any punishment after the DPC and before his/her actual promotion, the matter be referred to FHQ (Estt.I Branch) through Sector IsG for deletion of his/her name from the panel as well as cancellation of PCP.
- vi) Promotion should also not be given during the currency of punishment, if any.
- vii) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.

03. In case any of them is un-willing to move on promotion-cum-posting, a certificate should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and seniority later on and the same may be forwarded to this HQrs. (Estt-I Branch) through Sector IsG accordingly.

04. The promotion of Sub-Inspectors (Fire/Lab/Mech) to the rank of Insp/Fire against the year 2024 is subject to:- Order passed on 28.01.2022 by the Hon'ble Supreme Court in the case of Jarnail Singh and Ors V. Lachhmi Narain Gupta and Ors. (Civil Appeal No.629 of 2022 arising out of SLP © No. 30621 of 2011 and other connected matter as mentioned in DOPT OM No.36012/16/2019-Estt(Res) dated 12.04.2022.

05. In case, any of the SI(Fire/Lab/Mech) mentioned in **Appendix 'A'** has been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector from the **present place** of posting under intimation to this Dte. However, in case any of the individual has been posted out to another Sector repeat another Sector, cases of such personnel may be taken up with this Dte for amendment of PCP.

06. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of Inspector/Fire in the unit. The Charge assumption reports and Service Order Part-I regarding promotion may be submitted to this HQrs (Estt-I Branch) by the concerned units and appointing authority respectively immediately on their assumption of charge.

07. This promotion-cum posting order to the rank of Insp/Fire will override IST-2024 posting in the rank of SI (Fire/Lab/Mech), if any.

08. All concerned sectors are requested to ensure compliance as under:-

- a) Allotment of Zones/Units, assumption of charge etc. to be updated on "Posting Order Monitoring System" software as per instructions issued vides this Dte. Msg No. (5450) dated 12.10.2021.
- b) Allotment of Units by the Sector by : 12.04.2024
- c) Relieving of personnel on PCP by : 19.04.2024
- d) Date of submission of relieving compliance to Estt-II/FHQ by : 26.04.2024


