It is proposed to sponsor eligible and willing officers in the rank of Commandant/Exe and Deputy Commandant/Exe for deputation to the post of Consultant {The post carries a Grade Pay of Rs.7600/- in the Pay Band 3 of Rs.15600 -39100 (which is equivalent to the post of Commandant in CISF)} in National Institute of Disaster Management, New Delhi on deputation basis.

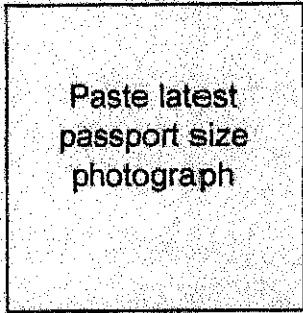
