The allocation of Central Pool MBBS/BDS seats for the Academic year 2024-25 for the wards of CAPFs/AR personnel is awaited from MHA/MoH&FW. In case of any amendment in instructions/guidelines and number of seats allocated for the wards of CAPFs/AR, the same will be intimated on receipt from MHA/MoH&FW. In the last academic session 2023-24, 26 seats for MBBS and 3 seats for BDS were allocated by MHA/MoH&FW under Central Pool quota.

O2. Applications of the eligible wards of Combatised Force personnel who have qualified National Eligibility cum Entrance Test (NEET)- 2024 are to be forwarded to MHA under Govt. Scheme prescribed for central pool MBBS/BDS seats for CAPFs/AR in the following category.

(i) PRIORITY -I : Wards/Widows of those Killed in Action (i.e Those who are eligible

for LPA -Liberalized Pensionary awards.

(ii) PRIORITY-II : Wards/widows/ wives of personnel permanently disabled in action

and boarded out from service.

(.) PRIORITY -III : Wards of all serving and retired personnel.
