It is proposed to sponsor eligible and willing officers in the rank of DIG/Exe for deputation in NDRF.

2. The ADGs (North/APS/South) and all Sector IsG are therefore requested to forward the nominations of willing and eligible officers alongwith their bio-data as per Annexure-I in respect of DIG/Exe who fulfil the norms of MHA's deputation policy guidelines dated 22.11.16 and the following RRs of NDRF by **31.07.2024** for consideration of their case for deputation to NDRF :-

Officers from the Central Paramilitary Forces and Indian Police Service:-

(i) holding the post of DIG on regular basis or empanelled to hold the post of DIG

(ii) Should be in Medical Category SHAPE-I (period of deputation will be for three years extendable to five years. However, in the case of IPS, the period of deputation will be governed by tenure policy specified by MHA for IPS.

3. Nominations which are not routed through ADGs concerned or received with incomplete records or received after due date, will summarily be rejected. Nominal roll in respect of eligible and willing officers in the rank of DIG/Exe with willingness certificate may be forwarded in Excel format (using Alt+Enter key in single cell) as per Appendix-A to this Directorate within the stipulated time.
