Subject: Promotion Cum Posting to the rank of Insp/Steno for the year- 2025.

The SIs/Steno mentioned in <u>Appendix-''A''</u> are found fit by the DPC held during the year 2025. They are promoted to the rank of Inspector (Steno) on regular basis at Level-7 in the pay Matrix, Rs.44,900-1,42,400 (Old pay scale Rs.9300-34800+GP 4600 (PB-2) and posted to the Sectors/Units as shown against their names. They may be adjusted against similar or higher rank. Their promotion will take effect from the date(s) they assume charge as Inspector/Steno in the new place of posting.

- 2. Before promoting them, it should be ensured that they fulfill the following conditions:
 - i) They are confirmed in the entry grade or in the present rank.
 - ii) They have successfully completed the promotion cadre course of Inspector/Steno.
 - iii) They should have been in medical category Shape-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled SI/Steno after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in para 2(d) of CISF HQrs letter No. (655) dated 12.08.2024, any person who has been declared fit by the DPC subject to attaining of Shape-I medical categorization, shall be promoted only after regaining his/her Shape-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2025. In case, he/she does not regain Shape-I medical categorization by 31.12.2025, his/her case will be considered afresh by the next DPC.
 - iv) No DE/Vigilance/Criminal Proceedings are pending against them.
 - v) Promotion should not be given, in case an empanelled SI/Steno is awarded any punishment after the DPC but before his/her actual promotion. If an empanelled SI/Steno is awarded any punishment after the DPC but before his/her actual promotion, the matter may be referred to FHQ (Estt.I Branch) through Sector IsG for deletion of his/her name from the panel as well as cancellation of PCP.
 - vi) Promotion should also not be given during the currency of punishment, if any.
 - vii) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.
- 3. In case any of them is un-willing to move on promotion-cum-posting, a certificate should be obtained from the concerned person that he/she is willing to forgo his/her promotion and will not claim promotion and seniority later on and the same may be forwarded to this Directorate (Estt.I Branch) through Sector IsG accordingly.
- 4. The charge assumption report and Service Order Part-I regarding promotion may be submitted to this HQrs. (Estt-I Branch) by the concerned Units and appointing authority respectively immediately on their assumption of Charge.
- 5. The promotion of SIs/Steno to the rank of Insp/Steno against the year 2025 is subject to :
 - i) Order passed on 28.01.2022 by the Hon'ble Supreme Court in the case of Jarnail Singh and Ors. V. Lachhmi Narain Gupta and Ors.(Civil Appeal No.629 of 2022 arising out of SLP (C) No.30621 of 2011) and other connected matters as mentioned in DoPT OM No.36012/16/2019-Esttt.(Res.) dated 12.04.2022.
 - ii) Promotion of SI/Steno to Insp/Steno is subject to outcome of WP No.4000/2023 filed by Insp/Steno Satyawan Singh & others before the Hon'ble High Court of Delhi.
