# SERVICE ORDER PART-I NO. 6 / 2025

### Sub:- PROMOTION-CUM-POSTING FROM ASI(FIRE/LAB) TO THE RANK OF SI(FIRE/LAB) FOR THE YEAR-2025.

The ASI/(Fire/Lab) mentioned in <u>Appendix –"A"</u> are found fit by the DPC-2025 and empanelled for promotion to the rank of SI(Fire/Lab) on regular basis in the Pay Matrix, Rs.35,400 – 1,12,400 (for GP-4200 level-6) and posted to the Sectors/Units as shown against their names. They may be adjusted against similar rank. Their promotion will take effect from the date(s) they assume charge as SI(Fire/Lab) in the new place of posting.

Before promoting them, it should be ensured that they fulfill the following conditions:
i) They are confirmed in the entry grade or in the present rank.

ii) They have successfully completed the promotion cadre course of SI (Fire/Lab).

iii) They should have been in medical category SHAPE-I before being declared fit by the DPCs and if there is any deterioration in the medical categorization of an empanelled ASI (Fire/Lab) after the DPC and before his/her actual promotion, the promotion will be withheld. Further as per MHA's directions dated 27.04.2012, incorporated in para 2(d) of CISF HQrs letter No.(656) dated 12.08.2024, any person who has been declared fit by the DPC subject to attaining of SHAPE-I medical categorization, shall be promoted only after regaining his/her SHAPE-I medical categorization, before completion of the vacancy year i.e. not later than 31.12.2025. In case, he/she does not re-gain SHAPE-I medical categorization by 31.12.2025, his/her case will be considered afresh by the next DPC.

iv) No DE/Vigilance/criminal proceedings are pending/contemplated against them.

v) Promotion should not be given, in case an empanelled ASI(Fire/Lab) is awarded any punishment after the DPC and before his/her actual promotion. If an empanelled ASI (Fire/Lab) is awarded any punishment after the DPC and before his/her actual promotion, the matter be referred to FHQ (Estt.I Branch) for deletion of his/her name from the panel as well as cancellation of PCP through concerned Sector HQrs.

vi) Promotion should also not be given during the currency of punishment, if any.

vii) In the case of SC/ST candidates, a certificate to this effect in prescribed format from the competent authority is available in their service documents.

viii) It may also be mentioned that on promotion, they shall be on probation for a period of two years in the rank of SI (Fire/Lab) from the date of assumption of charge and their promotion will be subject to satisfactory completion of their probation period.

3. In case any of them is un-willing to move on promotion-cum-posting, a certificate should be obtained from the concerned person that he is willing to forgo his promotion and will not claim promotion and seniority later on and the same may be forwarded to this HQrs. (Estt.I Branch) through Sector IsG accordingly.

4. The charge assumption report and Service Order Part-I regarding promotion may be submitted to this HQrs. (Estt-I Branch) by the concerned Units and appointing authority respectively immediately on their assumption of Charge.

5. The promotion of ASI/(Fire/Lab) to the rank of SI/(Fire/Lab) against the year 2025 is subject to:-

 i) Order passed on 28.01.2022 by the Hon'ble Supreme Court in the case of Jarnail Singh and Ors. V. Lachhmi Narain Gupta and Ors.(Civil Appeal No.629 of 2022 arising out of SLP (C) No.30621 of 2011) and other connected matters as mentioned in DoPT OM No.36012/16/2019-Esttt.(Res.) dated 12.04.2022.

6. In case, any of the ASI/(Fire/Lab) have been posted out to another unit in the same sector, their promotion-cum-posting may be issued by the concerned Sector from the present place of posting under intimation to this Dte. However, in case any of the individual has been posted out to another Sector repeat another Sector, case of such personnel may be taken up with this Dte for amendment of PCP.

7. Necessary Service Order Part-I will be published by the appointing authority on assumption of charge of the post of SI/(Fire/Lab) in the unit.

8. This promotion cum posting order to the rank of SI/(Fire/Lab) will override AT-2025 posting in the rank of ASI/(Fire/Lab), if any.

9. Sectors IsG will allot unit as per the indicative unit allotted. However, for administrative reasons and on case to case basis, the Sector IsG can change the units under intimation to FHQ with justification.

10. All concerned sectors are requested to ensure compliance as under:-
