

**REVISED DETAILS / INSTRUCTION FOR GRANTING DG'S MERIT
AWARD IN ACADEMICS AND SPORTS FOR THE YEAR 2016-17**

1. Name of the Scholarship

- A. "Director General's Merit Award in Academics"
B. "Director General's Merit Award in Sports"

2. Number of Scholarship

- A. For academic achievers - 100 (one time payment only)
B. For sports achievers - 10 (one time payment only)

3. Amount for Scholarship (category wise)

A. For Academic achievers:-

(i) For 95% and above marks in 10+2 level

- i. For Girls : Rs. 27,000/- { One time grant }
ii. For Boys : Rs. 25,000/-

(ii) For 90% and above marks but below 95% marks in 10+2 level

- i. For Girls : Rs. 23,000/- { One time grant }
ii. For Boys : Rs. 20,000/-

B. For Sports achievers:-

- i. For Girls : Rs. 27,000/- { One time grant }
ii. For Boys : Rs. 25,000/-

Eligibility Conditions:- The following would be eligible for the scholarships:-

- i. Wards of the serving CISF personnel of all ranks.
ii. Wards of the CISF personnel of all ranks Killed in Action.

(A) For Academic Achievers:-

- The students should have secured minimum 90% at the 10+2 level or equivalent overall aggregate in any stream i.e. Science, Commerce and Arts for which he/she has appeared.
- Students must have passed 10+2 level on regular basis from schools / colleges / boards recognized from the concerned UT/State/Central Govt./recognized regulatory body.
- Students either passing 10+2 level marks in more than one attempt or improving marks obtained in subsequent attempts or through supplementary exam thereof will not be eligible for scholarship.

- Students passing 10+2 level through correspondence / distance education will not be eligible for scholarship.
- All applications received will be listed in order of merit as per the aggregate percentage (%) of marks obtained in the best five main subjects in the 10+2 board examination.
- The number of scholarships awarded in a year for academic achievers would be restricted to 100 students in order of merit as above.

(B) For Sports Achievers:-

(i) Individual Event:-

- Should have represented a State in National Games / National Championship in Senior / Junior level during the last edition. The National Games / National Championship should be conducted by the Units affiliated with the Indian Olympic Association and conducted with the approval of the National Federations. (List enclosed)
- Should have won any medal in all India / Zonal Inter-University Championship during the last edition.
- Should have won any Medal in National School Games / Championship during the last edition. The National School Games/Championship should be conducted by the School Games Federation of India.

(ii) Team Event:-

- Should have represented State team in National Games / Championship in Senior / Junior level during the last edition. The National Games / National Championship should be conducted by the Units affiliated with the Indian Olympic Association and conducted with the approval of the National Federations. (List enclosed)
- Member of medal winning team in All India / Zonal Inter-University Championship during the last edition.
- Any Medal in National School Games / Championship during the last edition. The National School Games/Championship should be conducted by the School Games Federation of India.

[The person should have been a playing member of the team during the last edition]

- **Marks for Individual / Team event will be awarded as under:-**

S.N	Games / Event	Gold	Silver	Bronze	Participation
(i)	National Games /Championship	10	9	8	3
(ii)	Inter University Championship	6	5	4	2
(iii)	National School Games / Championship	5	4	3	1

- In case of tie, more weightage would be given to “individual event” than “team event”.
- Only the highest achievement of a candidate shall be considered for the purpose.
- The period under consideration shall be July to June of the preceding year.

- The number of scholarships awarded for sports achievers would be restricted to 10 per year as per order of merit determined by marks as specified above.

5. Preparation and forwarding of Merit List :-

- All Sector IsG will circulate the instructions to field formations and call for the applications from eligible candidates only latest by 15th July of each year.
- All Sector IsG will nominate a Board of Officers (BOO) for scrutiny of applications at each Sector.
- The BOO will ensure that applications are filled up properly as per the guidelines and all documents are in order. Board of Officers will ensure that no application of ineligible ward is forwarded to Welfare Directorate.

Board of Officers will also countersign the checklist of each application in the following proforma :-

“Certified that the application / case file has been thoroughly checked according to instructions issued by FHQ and all connected documents as per check list are available with application”. Shri/Miss _____ S/o / D/o _____ is eligible for granting of _____ scholarship for the academic year _____ and the above ward has not ever been awarded with the DG’s Merit Award in Academics / Sports.

Consolidated list (category wise) of all the eligible students are required to be forwarded to Welfare Directorate, FHQrs, New Delhi in the soft copy as well as hard copy by **30th July** every year.

6. Documents:-

The following documents are required alongwith the nominations for scholarship:-

- Self attested copy of 12th class mark sheet.
- Bonafide regular studentship certificate to be issued by the registrar / Dean / Principal / Institution pertaining to course for which scholarship is claimed.
- Serving Certificate issued by the Head of the Office.
- Certificate issued by concerned authority in support of sports events mentioned above.
- Copy of passbook/leaf of cancelled cheque of wards account.
